I, the undersigned, hereby make, subscribe, acknowledge, and file with the Secretary of State of the State of Florida these Articles of Incorporation for the purpose of forming a not for profit corporation in accordance with the laws of the State of Florida.

**ARTICLE I**

**NAME**

**ARTICLE III**

**PURPOSES**

The purpose(s) for which the corporation is organized is:

To operate the association exclusively for non-profit purposes within the meaning of Section 501 (c) (3) of the Internal Revenue Code or the corresponding section of any future federal tax code.

To be in compliance with the bylaws of the United States Bowling Congress, the national organization, in order to be chartered as a not for profit local association.

To promote the game of American Tenpins within the areas of North and Central Brevard County with assistance, guidance, and direction of the United States Bowling Congress (USBC).

To provide equal opportunity for all in the sport of bowling without regard to race, religion, age, disability, or national origin.

To support and conduct bowling competition.

## **ARTICLE IV**

### **MANNER OF ELECTION**

The manner in which the directors are elected or appointed is as follows:

The officers and directors shall be elected by ballot at the annual open membership meeting of the association by the majority vote of those present.

- b. The board fills vacancies in officer positions.
