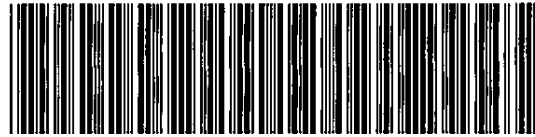

**ARTICLES OF INCORPORATION  
OF  
THE IHDO OF FLORIDA, INC.  
(A NOT-FOR-PROFIT)**

Pursuant to Section 617.0202 Florida Statutes, the undersigned subscriber (s) is desirous of forming a not-for-profit corporation under the laws of the State of Florida, and hereby petition the Secretary of State for approval of such incorporation under the following proposed Certificate of Incorporation.

**ARTICLE I  
NAME**

The name of the Corporation is **THE IHDO OF FLORIDA, INC.**, a Not-for-Profit organization.

**ARTICLE II  
PLACE OF BUSINESS**

The principal place of business and mailing address of the corporation is 1050 Wilshire Circle West, Pembroke Pines Florida, 33027, as deemed appropriate by the Board of Directors/Trustees.

**ARTICLE III  
PURPOSE**

The organization is organized exclusively for the purpose of promoting responsible health education, diagnosis, and treatment including but not limited to population epidemiology, etiology and causes and expertise to reduce the incidence and prevalence

of cancer among cross cultural groups including Haitians, African Americans, Latin Americans and Latinos. The corporation will also provide new and scientific knowledge, awareness, and compassion among members, physicians, and associates. **THE IHDO OF FLORIDA, INC** wishes to communicate and provide advanced knowledge and leadership to its members physicians, nurses and other health professionals, without regard to gender sexual preference, origin, nationality, race, political affiliation and religious beliefs. Pursuant to Florida Statutes Section 212.07 (7) and within the meaning of Section 501 ©(3) of the Internal Revenue Code of 1986 or the corresponding provision of any future Federal tax code.

#### **ARTICLE IV**

##### **PERMITTED ACTIVITIES**

Notwithstanding, any other provision of these Articles of Incorporation, this organization shall not carry on any activities not permitted to be carried on by an organization exempt from Federal Income Tax, under Section 501 ©(3) of the Internal Revenue Code of 1986, or the corresponding provision of any future United States Internal Revenue Law.

#### **ARTICLE V**

##### **ELECTION OF DIRECTORS/TRUSTEES**

The method of election or appointment of the directors or trustees and the manner of their admission are provided for in the bylaws of **THE IHDO OF FLORIDA, INC.**

**ARTICLE VI  
DURATION AND BEGINNING  
OF CORPORATE EXISTENCE**

The Corporation shall exist perpetually; the corporate existence shall commence as of the filing of the Articles of Incorporation with the Secretary of State of Florida and the Federal Identification Number.

**ARTICLE VII  
INITIAL BOARD DIRECTORS**

Directors and Trustees of the Corporation shall be elected or removed in accordance with the procedures provided for in the bylaws. The number of Directors/Trustees may be increased or decreased from time to time, in the manner provided in the By-laws of **THE IHDO OF FLORIDA, INC.** The numbers constituting the initial Board of Directors of the Corporation is **FIVE** and the names and address of these persons who are to serve initially are as follows.

## **ARTICLE VIII**

### **DEDICATION OF ASSETS**

Upon dissolution or winding up of this corporation, its assets remaining after payment, or provision for payment, of all debts and liabilities of the corporation, shall be distributed to a non-profit fund, foundation or corporation which is organized and operated exclusively for educational and cultural purposes and which has established its tax exempt status under Section 501 ©(3) of the Internal Revenue Code of 1986, or corresponding provisions of any subsequent federal tax laws.

## **ARTICLE IX**

### **DISTRIBUTION OF EARNINGS**

No part of the net earnings of the corporation shall insure to the benefit of, or be distributable to its members, trustees, directors, officers or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of Section 501 ©(3) purposes. No substantial part of the activities of the corporation shall be the carrying of propaganda, or otherwise attempting to influence legislation, the corporation shall not participate in, or intervene in any political campaign on behalf of or in opposition to any candidate for public office.

## **ARTICLE X**

### **REGISTERED AGENT**

Pursuant to Sections 617.0501 and 617.0505, Florida Statutes, **THE IHDO OF FLORIDA, INC.**, has designated Dr. Frantz Delva, as the initial Registered Agent of this corporation and the street address of the initial Registered Agent is 3101 NW 47Terrace Suite 129-4, Lauderdale Lakes, Florida 33319. The principal place of business of the corporation in the State of Florida is 1050 Wilshire Circle West, Pembroke Pines, Florida 33027.

## **ARTICLE XI**

### **SHARES**

This corporation is organized under a NON-Stock basis.

## **ARTICLE XII**

### **INCORPORATORS**

The names and the street address of each Incorporator of the Articles of Incorporation are recorded in the By-laws of the corporation.

### **ARTICLE XIII**

#### **BYLAWS**

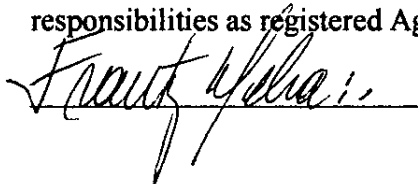

### **ARTICLE XIV**

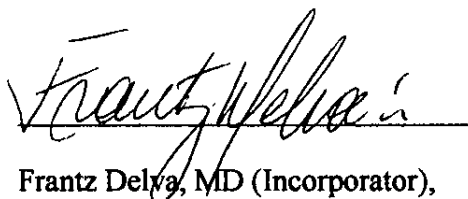
#### **EXECUTION**
