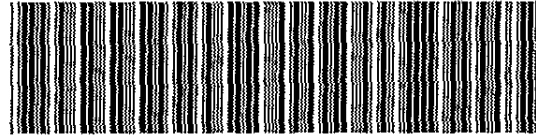

**Article 8 - OTHER PROVISIONS**

- 8.1 This corporation is organized exclusively for charitable purposes within the meaning of section 501 (c) (3) of the Internal Revenue Code. Notwithstanding any other provision of these articles, the corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from Federal income tax under section 501 (c) (3) of the Internal Revenue Code of 1986 (or corresponding provision of any future United States Internal Revenue law) or (b) by a corporation contributions to which are deductible under section 170 (c) (2) of the Internal Revenue Code of 1986 (or corresponding provision of any future United States Internal Revenue law).
- 8.2 Upon the dissolution of this corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501 (C) (3) of the Internal Revenue Code (or corresponding provision of any future United States Internal Revenue code), or shall be distributed to the Federal government, or to a state or local government, for a public purpose. Any such assets not so disposed of shall be disposed of by the Court of Common Pleas of the county in which the principal office of the corporation is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.
- 8.3 This Chapter will have no capital stock.
- 8.4 In the event of liquidation or distribution of all or any part of the assets of the Chapter in case of dissolution or otherwise, such assets will be distributed to Hendricks Avenue Elementary.

**ADOPTION**

This Constitution of the Florida First Coast Chapter of the National Association of Church Business Administration is hereby adopted by a two-thirds majority vote of the active voting membership on January 15, 2003.

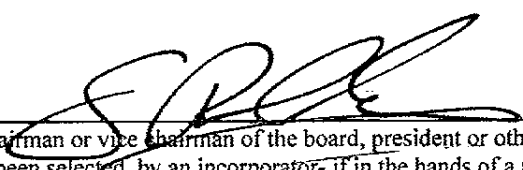
