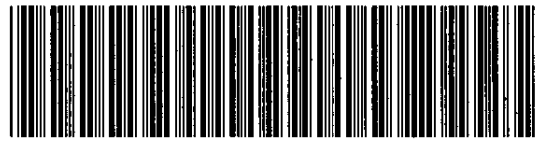




Articles of Dissolution

Pursuant to section 617.1402 - 1403 of the Florida Statutes, this corporation submits the following Articles of Dissolution:

1. The name of the corporation is Community Pregnancy Center, Inc., and;
2. The effective date of dissolution is September 30th, 2008 and;
3. The corporation has no members and the Dissolution was approved by the Board of Directors on July 28th, 2008. The number of votes cast for dissolution was sufficient for approval, and;


