ARTICLE I

NAMES AND ADDRESS

The name of the corporation is: **Gulf Coast Niseido Ju Jitsu Academy, Inc** (the "Academy"). The mailing address of the Academy is 5060 Sycamore Drive, Naples, Florida 34119. The street address of the Academy is 5060 Sycamore Drive, Naples, Florida 34119.

ARTICLE II

DURATION

The term of existence of the Academy is perpetual and the corporate existence will commence on the filing of these Articles with the Florida Department of State.

ARTICLE III

PURPOSE

The Academy is organized as a club for members engaged in the practice of the martial art of Niseido Ju Jitsu and the purpose of the Academy is to educate and instruct members in the martial art of Niseido Ju Jitsu.

The Academy shall not engage in any activity not permitted to be engaged in by an organization exempt from Federal income tax under section 501 (c) (7) of the Internal Revenue Code of 1986 or the corresponding provision of any subsequent United States Internal Revenue Law.

ARTICLE IV

DIRECTORS

There shall be three or more members of the Board of Directors, each of which shall be eighteen years of age or older. The initial Board of Directors shall be appointed by the Incorporator. The number of directors and the method of election of the directors of the Academy are as set forth in the bylaws.

ARTICLE V

REGISTERED OFFICE AND AGENT

The initial registered office of the Academy shall be located at 5060 Sycamore Drive, Naples, Florida 34119. The initial registered agent of the Academy at that address shall be Richard B. Parlante.

ARTICLE VI

MEMBERS

The Academy shall have members. Membership shall be on a non-stock and non-equity basis. The Bylaws of the Academy shall contain provisions relating to qualifications for membership, the rights of members, and other such matters. Neither the Bylaws nor any other governing instrument or written statement of the Academy shall contain any provision that provides for discrimination against any person on the basis of race, color, religion or gender.

ARTICLE VII

FINANCIAL MATTERS

The Academy is not organized for monetary profit, nor shall it have any power to issue certificates of stock or to declare dividends, and no part of the net earnings of the Academy shall inure to the benefit of any member, director, or private individual (except as reasonable compensation for services rendered). The balance, if any, of all of the moneys received by the Academy from its operations, after payment in full of all debts and obligations of the Academy, shall be used exclusively for the purposes set forth in Article III herein above. Nothing in the foregoing, however, shall limit the Academy in accumulating surplus funds for the expansion or security of its own operations. Upon the dissolution of the Academy, any accumulated moneys or assets, which have not theretofore been paid in pursuit of the corporate purpose, shall be paid and distributed to any 501 (c) (3) organization that supports youth education.

ARTICLE VIII


