ARTICLES OF INCORPORATION

THE UNDERSIGNED, a majority of whom are citizens of the United States desiring to form a Non-Profit Corporation under the Non-Profit Corporation law of the part of the United States of the

ARTICLE I

The name of this Corporation shall be: Hydrogeology Consortium, Inc.

ARTICLE II

The place in this state where the principal office of the Corporation is to be located is the City of Tallahassee in Leon County. The principal office is currently located at Florida State University, 18 Keen Building, 97 South Woodward Avenue, Tallahassee, Florida 32306-4166.

ARTICLE III

Said corporation is organized primarily for scientific purposes, including gathering and compiling scientific research data for the general purpose of applying scientific principals to decision and policy making related to ecosystem conservation and environmental protection. The Consortium also conducts education and outreach activities such as conducting workshops, publishing workshop proceedings and distributing such publications to organizations that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code. The corporation is relying on the laws of the state of

incorporation to satisfy the requirements of section 508(e) of the Internal Revenue Code relating to private foundation governing instruments.

The purpose for which the corporation is organized is to cooperatively provide scientific knowledge applicable to water resource management and protection.

ARTICLE IV

The names, addresses, and titles of the persons who are initial trustees of the corporation are as follows:

The directors of the corporation are elected according to the bylaws.

ARTICLE V

No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and make payments and distributions in furtherance of the purposes set forth in Article Three hereof. No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislations, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) a political campaign on behalf or in opposition to any candidate for public office. Notwithstanding any other provisions of these articles, the corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from federal income tax under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or (b) by a corporation, contributions to which are deductible under section 170(c)(2) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

ARTICLE VI

Upon the dissolution of the corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not so disposed of shall be disposed of by a Court of Competent Jurisdiction of the county in which the principal office of the corporation is then located, exclusively

for such purposes or to such organization of organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.
