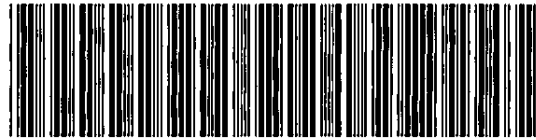



The Undersign incorporator (s). For the purpose of forming a corporation Pursuant to Chapter 617 Florida Statutes under the Florida Non For Profit Corporation Act, hereby adopt(s) and shall set fourth:

**Article I**

#### Article VII


No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to its members, trustee, directors, officers or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered to make payments and distributions in furtherance of section 501 ( c ) ( 3 ) purposes. No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of political statements) any political campaign on behalf of or in opposition to any candidate for public office.


Notwithstanding any other provision of these articles, the corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from federal income tax under Section 501 ( c ) ( 3 ) of the Internal Revenue Code (or corresponding section of any future federal tax code) or (b) by a corporation contributions to which are deductible under Section 170 ( c ) (2) of the Internal Revenue Code (or corresponding section of any future federal tax code.)

#### Article VIII

Upon dissolution of this corporation assets shall be distributed for one or more exempt purposes within the meaning of Section 501 ( c ) ( 3 ) of the Internal Revenue Code, i.e. charitable, educational, religious or distributed for a public purpose.
