Article of Amendment to Articles of Incorporation of Brevard County Blues Society, Inc.

Pursuant to the provisions of section 617.1006, Florida Statues, this Florida Not For profit Corporation adopts the following amendments to its Articles of Incorporation:

Amendments Adopted:

Article I - Name

The name of the corporation shall continue to be Brevard County Blues Society, Inc.

Article II - Principal Office

The principal place of business and mailing address of this corporation shall be 1623 Nebraska Street NE, Palm Bay, Florida.

Article III - Purpose

The purpose for which the corporation is organization is:

The purposes for which the corporation is organized are exclusively charitable and educational within the meaning of section 501(c)(3) of the Internal Revenue Code of 1986 or the corresponding provision for any further United States Internal Revenue Law.

Those purposes are:

- 1. To support, promote and preserve the Blues in Brevard County.
- 2. Provide & Sponsor Musicians' Hospitality tents at local Blues Shows and Festivals.
- 3. Provide financial support to send local qualified blues musicians to Memphis, Tennessee each year to compete in the International Blues Challenge.
- 4. Provide a "Benevolence Fund" which provides support to the families of our local blues musicians who have passed away to enable them to seek qualified legal counsel in settling their loved one"s financial affairs.

5. Provide a "Scholarship Fund" available to qualified children of area blues musicians who have been accepted into an accredited junior or senior college.

Notwithstanding any other provisions of these articles, this organization shall not carry on any activities not permitted to be carried on by an organization exempt from Federal income tax under section 501(c)(3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue Law.

In the event of dissolution, the residual assets of the organization will be turned over to one or more organizations which themselves are exempt as organizations described in sections 501(c)(3) and 170(c)(2) of the Internal Revenue Code of 1986 or corresponding sections of any prior or future Internal Revenue Code, or to the Federal, State, or local government for exclusive public purpose.

Article IV - Manner of Election

The manner in which the directors are elected or appointed:

The officers of the Corporation shall be a President, a Vice-President, and a Secretary-Treasurer, and/or such other offices as may be constituted under the By-Laws; all of which directors shall be elected to hold office as provided in the By Laws.
