AMENDMENT TO THE ARTICLES OF INCORPORATION OF ARTISTS ENCLAVE HOMEOWNERS ASSOCIATION, INC.

The Articles shall be amended as follows:

(Note: Words stricken are deletions; Words underlined are additions.)

ARTICLE 6 BOARD OF DIRECTORS

[Section 6.1 through Section 6.3 shall remain unchanged]

6.4 Qualification and Term. Directors need not are required to be members of the Association. In order to provide for continuity of experience it is the intention of these Articles that a system of staggered terms be created and thereafter maintained. Thus, at the next election following the adoption of this amendment, five (5) Directors shall be elected. The three (3) Directors receiving the most number of votes shall be elected to two (2) year terms each and the two (2) Directors receiving the fourth and fifth most number of votes shall be elected to terms of one (1) year each. If the election is uncontested, the Directors shall determine which Directors take the longer terms by agreement and in the absence of agreement it shall be determined by the drawing of straws. Thereafter, all Directors shall be elected for a terms of two (2) years. A Director's term will end at the annual election at which his successor is to be duly elected, unless he sooner resigns or is removed as provided for in Article 6.5 herein. Directors shall be elected by the members as described in Article 6 herein.
