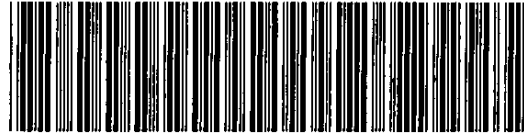

**ARTICLES OF INCORPORATION**

**In Compliance with Chapter 617, F.S., (Not for Profit)**

**OF**

**COALITION FOR URGENT RECOVERY AND EMPOWERMENT INC**

**A Non Profit Corporation**

The undersigned, being over the age of eighteen (18) years and competent to contract, for the purpose of organizing a Corporation not-for-profit pursuant to the laws of the **State of Florida**, Chapter 617, F.S., (Not for Profit) does hereby adopt the following Articles of Incorporation, and does hereby agree and certify as follows:

**ARTICLE I**

**NAME**

**COALITION FOR URGENT RECOVERY AND EMPOWERMENT INC**

**ARTICLE II**

**PRINCIPAL OFFICE**

**ARTICLE III**

**PURPOSE AND POWERS**

(1) The purpose for which the **COALITION FOR URGENT RECOVERY AND EMPOWERMENT INC.**, is organized and operated is exclusively for charitable, bridge to gap with other sources, religious, educational, and scientific purpose, including, for such purposes, the making of distributions to organizations that qualify as exempt organization under Section 501 (c) (3) of the Internal Revenue Code, or the corresponding section of any future federal tax code. The period of duration of the **Coalition for Urgent Recovery and Empowerment Inc.(C.U.R.E. Inc)** is perpetual unless dissolved according to law. **Coalition for Urgent Recovery and Empowerment Inc.(C.U.R.E. Inc)** existence shall commence upon the filing of these Articles of incorporation. Such purposes shall include, but are not limited to the following:

- (a) Encourage the hard to serve individuals with medical need, assisting individuals who are discriminate or insolated against because of chronic decease, stress, and temporary mental health, victims of domestic violence, sexual abuse or inappropriate behavior; through education, nutrition awareness, bridge to gap with other sources, emotional counseling & spiritual healing.

- (b) Educational training – by preparing and equipping individuals, families, and entrepreneurs for social and economical positioning through personal skill development, home ownership through available programs, wealth management, counseling and other financial success strategies.
- (c) Religious – To minister to those who are enslaved spiritually physically and emotionally through Christian evangelism counseling and social services that help to heal the total person. To transform individuals in need to individuals indeed. Encourage individuals with practical survival and life skills to help them be successful and achieve balance between work and home using Christian principle by the direction of the Lord Jesus Christ and under the leadership of the Holy Spirit in accordance with all of the Commandments and provisions as set forth in the Holy Bible.
- (d) Charitable – We believe a strong community lays within their greatest resource- its people. **Coalition for Urgent Recovery and Empowerment Inc.** (C.U.R.E. Inc) will strengthen families through community based education, mentoring, and counseling programs. We will offer job training and skill development workshops and seminars that go beyond tradition job readiness, personal and professional development.

(2) As a means of accomplishing the above purposes and methods, **Coalition for Urgent Recovery and Empowerment Inc.** (C.U.R.E. Inc) shall have the following powers:

- (a) To receive and accept gifts of money and property and to hold the same for any of the purposes of the **Coalition for Urgent Recovery and Empowerment Inc.** (C.U.R.E. Inc) and its work.
- (b) To raise and assist in raising funds for the purposes herein set forth, including the issuance of bonds or other instruments of credits.
- (c) To acquire, own, lease, mortgage and dispose of property both real and personal.
- (d) To accept property and donations in trust for religious or charitable purposes.
- (e) This **Coalition for Urgent Recovery and Empowerment Inc.** (C.U.R.E. Inc) will not have or issue shares of stock. No dividend will be paid, and no part of the income of The **Coalition for Urgent Recovery and Empowerment Inc.** (C.U.R.E. Inc) will be distributed to its Directors or Officers. However, the This **Coalition for Urgent Recovery and Empowerment Inc.** (C.U.R.E. Inc) may pay compensation in a reasonable amount to Officers, Directors, or committee Members for services rendered.

(3) The property of the The **Coalition for Urgent Recovery and Empowerment Inc.** (C.U.R.E. Inc) is irrevocable dedicated to religious, educational and charitable purposes, and no part of the net earnings of the The **Coalition for Urgent Recovery and Empowerment Inc.** (C.U.R.E. Inc) shall inure to the benefit of, or be distributable to its members, trustees, directors, officers or other private persons, except that the **Coalition for Urgent Recovery and Empowerment Inc.** (C.U.R.E. Inc) shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of Section 501 (c)(3) purposes.

(a) No substantial part of the activities of the **Coalition for Urgent Recovery and Empowerment Inc.** (C.U.R.E. Inc) shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the **Coalition for Urgent Recovery and Empowerment Inc.** (C.U.R.E. Inc) shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of, or in opposition to, any candidate for public office.

(b) The **Coalition for Urgent Recovery and Empowerment Inc.** (C.U.R.E. Inc) shall not:

- (1) Operate for the purpose of carrying on a trade or business for profit;
- (2) Accumulate income, invest income, or divert income, in a manner endangering its exempt status; or
- (3) Except to an insubstantial degree, engage in any activity or exercise any powers that are not in furtherance of the purposes of the **Coalition for Urgent Recovery and Empowerment Inc.** (C.U.R.E. Inc).

## **ARTICLE IV**

### **MANNER OF ELECTION**

Directors shall be elected as set forth in the **Coalition for Urgent Recovery and Empowerment Inc.** (C.U.R.E. Inc) Bylaws.

## **ARTICLE V**

### **INITIAL BOARD OF DIRECTORS**

The **Coalition for Urgent Recovery and Empowerment Inc.** (C.U.R.E. Inc) shall have three (3) directors initially. The number of directors may be either increased or diminished from time to time in accordance with the Bylaws, but shall never be less than three (3). ### **BYLAWS**

The power to adopt, alter, amend or repeal bylaws shall be vested in the Board of Directors.

Notwithstanding any other provision of these articles, the **The Coalition for Urgent Recovery and Empowerment Inc.** (C.U.R.E. Inc), shall not carry on any other activities nor permitted to be carried on:

(1) By a **Coalition for Urgent Recovery and Empowerment Inc.** (C.U.R.E. Inc), exempt from Federal income tax under Section 501(c)(3) of the I.R.S. Code (or corresponding section of the any future Federal tax code) or


(2) By **Coalition for Urgent Recovery and Empowerment Inc.** (C.U.R.E. Inc), contributions to which are deductible under Section 170(c)(2) of the I.R.S. Code (or corresponding section of any future Federal tax code.)

(b) Upon dissolution of the **Coalition for Urgent Recovery and Empowerment Inc.** (C.U.R.E. Inc), assets shall be distributed for one or more exempt purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future Federal tax code, or shall be distributed to the Federal government, or to a state or local government, for a public purpose.




