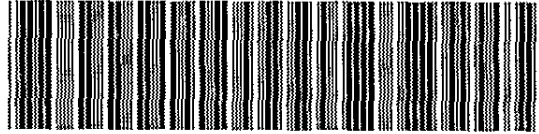

Article of Incorporation of the undersigned, a majority of whom are citizens of the United States, desiring to form a Non-Profit Corporation under the Non-Profit Corporation Law of the State of Florida, in compliance with Chapter 617, F.S., (Not for Profit) do hereby certify:

First: The name of the Corporation shall be Terry Parker Band Parents Association, Inc.

Second: The place in this state where the principal office of the Corporation is to be located is the City of Jacksonville, Duval County. The entity's mailing address shall be 7301 Parker School Road, Jacksonville, FL 32211

Third: Said corporation is organized exclusively for charitable, religious, educational, and scientific purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code. The primary nature and object of the corporation shall be:

- A. To aid in the establishment and promotion of the Terry Parker High School Band and Instrumental Ensembles.
- B. To cooperate and coordinate its efforts with the Director.
- C. To secure financial and other aids for improvement and assistance of the Band and Instrumental Groups.

Fourth: The names and addresses of the persons who are the initial subscribers of the corporation are as follows:

Fifth: The affairs of the corporation shall be managed by a Board of Directors, which shall be headed by a President with such other officers as shall be elected or appointed in such manner as the Board of Directors shall prescribe under the policies and procedures determined by the membership and recorded in the By-Laws of the corporation. The Board of Directors shall consist of the Officers of the Corporation and the Band Director. The Officers shall be a President, Vice President, 2nd Vice President, Secretary and Treasurer, and shall be elected at the annual business meeting of the Corporation to be held each year in February in lieu of the regular monthly meeting and shall hold office for a period of one year or until their successors are elected and installed.

Sixth: The names of the members of the Board of Directors and other officers who are to manage all of the affairs of the corporation until the first election or appointment under this charter is made, are as follows:





Seventh: No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article Third hereof. No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office. Notwithstanding any other provision of these articles, this corporation shall not, except to an insubstantial degree, engage in any activities or exercise any powers that are not in furtherance of the purposes of this corporation.


Eighth: Upon the dissolution of the corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not so disposed of shall be disposed of by a Court of Competent Jurisdiction of the county in which the principal office of the corporation is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.


We, the undersigned, being the original subscribers hereinbefore named for the purpose of forming a corporation not for profit, do make and file this certificate, hereby declaring and certifying that the facts herein stated are true, and accordingly have hereunto subscribed our names this 8th day of Nov 2005.



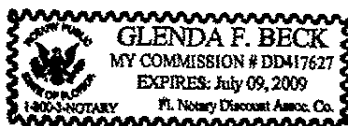
