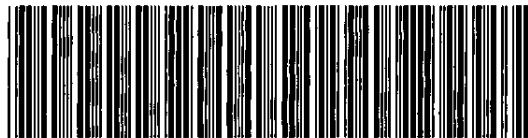



**ARTICLE OF INCORPORATION OF
WESTON ART GUILD, INC.**

The undersigned, all of whom are citizens of the United States, and residents of Broward County, Florida, desiring to form a corporation not-for-profit under the laws of the State of Florida, do hereby make these Articles of Incorporation and certify as follows:

ARTICLE I – NAME

The name of this Corporation shall be the WESTON ART GUILD, INC.

ARTICLE II – PRINCIPAL OFFICE

The place in Florida where the principal office of this Corporation is to be located is:

2795 Hackney Road
Weston, Florida 33331

ARTICLE III – PURPOSE

This Corporation is organized for the following purposes:

- A. To create a cultural atmosphere in Broward County, Florida and environs, by educating the public on the importance of all forms of visual art.
- B. To provide the community exposure to all forms of visual arts while promoting outlets for the work of its members.
- C. To give artists who are members of the guild activities that enhance their artistic ability, and provide them camaraderie.
- D. To conduct educational programs leading to more appreciation of art in the South Florida Community.

ARTICLE IV – BOARD OF DIRECTORS

ARTICLE V – RESTRICTIONS

- A. No part of the net earnings of the Corporation shall inure to the benefit of, or be distributable to its members, Trustees, officers, or other private persons, except that the Corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article Third hereof. No substantial part of the activities of the Corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the Corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office. Notwithstanding any other provision of these articles, the Corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from federal income tax under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or (b) by a corporation, contributions to which are deductible under section 170(c)(2) of the Internal Revenue Code, or the corresponding section of any future federal tax code.
- B. Notwithstanding any other provisions of these articles, this Corporation shall not, except to an insubstantial degree, engage in any activities or exercise any powers that are not in furtherance of the purposes of this Corporation.

ARTICLE VI – DISSOLUTION

Upon the dissolution of the Corporation, all corporate assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or shall be distributed to the federal government, for a public purpose. Any such assets not so disposed of shall be disposed of by a court of competent jurisdiction of the county in which the principal office of the Corporation is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine which are organized and operated exclusively for such purposes.

ARTICLE VII – DIRECTORS

The directors of this Corporation shall be elected as provided for in the bylaws which this Corporation shall enact.

ARTICLE VIII – OFFICERS

This Corporation shall have a president, one (1) or more vice presidents, and such other officers as are authorized by the bylaws which this Corporation shall enact.




