

ARTICLE I Name and Office Address

The name of the corporation is Marine Resource Enhancement, Inc.

The principal office and mailing address of the Corporation is 4255 US1 South, Unit 2, St. Augustine, FL 32086.

ARTICLE II

Duration

The corporation shall have perpetual existence.

ARTICLE III

<u>Purpose</u>

Educational, scientific, and charitable. Design, build, and place artificial reef systems in marine ecosystems. Save landfill space by placing clean construction debris in offshore marine environments. More specifically, such purposes, include, but are not limited to the advancement of scientific knowledge by the study of the effects of man made structures on the near shore and off shore marine ecosystems.

Corporation will serve an educational purpose by having marine science, biology, and building & materials students design, place and observe the results of these structures.

A humanitarian, charitable, aspect of this organization will be provided by an increase in the number and type of marine species.

ARTICLE IV Address

The initial registered office of this corporation is 4255 US1 South, Unit 2, St. Augustine FL, 32086. The name of the initial registered agent at such address is David Miles.

ARTICLE V

Director

The corporation shall have one director and chairperson initially, whose name and street address are as follows:

ARTICLE VI

ARTICLE VII

Board of Directors - Method and Term of Appointment

- 1. The Board of Directors (BOD) shall consist of five individual members of Marine Resource Enhancement (MRE) and shall include a chairperson, a secretary and a treasurer.
- 2. The BOD shall maintain awareness of and discuss issues relevant to the organizations goals and purposes and help to further MRE's goals and purposes.
- 3. The BOD shall hold face to face or teleconferencing meetings on a regular semiannual basis and in addition may hold special meetings if necessary. A forum consists of 3 BOD members.
- 4. The time, place and agenda of each BOD meeting shall be publicized one week in advance of the meeting, or as soon thereafter as feasible.
- 5. The chairperson is responsible for calling BOD meetings and organizing the agenda. For purpose of incorporation papers, the chairperson shall also be known as the president.
- 6. The secretary shall take minutes at all BOD meetings and make them available to all BOD members in a timely fashion.
- 7. The treasurer shall collect all dues and other monies and deposit them in the organizations' checking account, shall pay all bills by check, shall keep records of all transactions and shall publicly post a quarterly financial report.
- 8. Board members shall be appointed by the chairperson to two year terms that begin on January 1 of each year. Terms of office shall be staggered with three board positions being filled in even numbered years and two board positions being filled in odd numbered years.
- 9. If an office is vacated before expiration of its term, an appointment to fill the vacancy shall take place within three months. A partial term so created of six months or less will not count toward the two-consecutive-term limitation.
- 10. A BOD member may be removed by the president.

ARTICLE VIII

Miscellaneous

The following guidelines will apply to the operations of the corporation:

- 1. No part of the net earnings of the corporation shall inure to the benefit of, or be distributed to its members, trustees, officers or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article III.
- 2. Except as provided by law, a director of the corporation is not personally liable to the corporation or its members for monetary damages for a breach of the officers fiduciary duties.
- 3. The corporation assumes all liability to any person other than the corporation or its members of all acts or omissions of a director incurred in good faith performance of their duty as an officer occurring on or after the date of incorporation.

ARTICLE IX

Disolvement

Marine Resource Enhancement, Inc. may be dissolved by action of the president. In this event all property belonging to MRE shall be sold. Any remaining cash assets, after paying final bills shall be donated to a charitable organization or donated to another 501 c 3. All board members shall then be released from their obligations and the corporation dissolved.

ARTICLE X

Amendment

These articles of Incorporation may be amended in the manner provided by law. Every amendment shall be approved by the Board of Directors, at a BOD meeting by a majority of the board.
