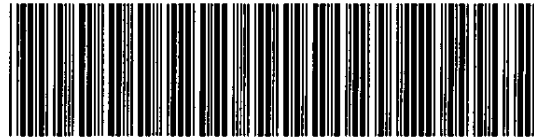

**ARTICLES OF INCORPORATION**  
**OF**  
**CHRISTIAN MARTIAL ARTIST COALITION, INC.**

The undersigned, for the purpose of forming a nonprofit corporation under Florida Statutes Chapter 617, do hereby make and adopt the following Articles of Incorporation.

**ARTICLE I**

**NAME**

The name of the corporation is **CHRISTIAN MARTIAL ARTIST COALITION, INC.** and its principle place of business 4546 Pine Street, Fruitland Park, Florida 34731 with a mailing address of 4546 Pine Street, Fruitland Park, Florida 34731.

**ARTICLE II**

**NOT FOR PROFIT**

The Corporation is a nonprofit corporation under the laws of the State of Florida. The Corporation is not formed for pecuniary profit. No part of the income or assets of the Corporation is distributable to or for the benefit of its Members, Trustees or Officers, except to the extent permissible under law.

**ARTICLE III**

**COMMENCEMENT OF CORPORATE EXISTENCE**

In accordance with the laws of the State of Florida, the date when corporate Existence shall commence is the date of subscription and acknowledgment of these Articles of Incorporation.

## **ARTICLE IV**

### **PURPOSES**

The Corporation is organized, and shall be operated exclusively for the following Purposes:

- A. To provide a safe environment for under privileged children in the community to obtain knowledge and instruction in martial arts for self-defense.
- B. To exercise all rights and powers and conferred by the laws of the State of Florida Upon nonprofit corporations, including without limiting the generality of the foregoing, to acquire by bequest, devise, gift, purchase, lease or otherwise any property of any sort or nature without limitation as to its amount or value, and to hold, invest, reinvest, manage, use, apply, employ, sell, expend, disburse, lease, mortgage, convey, option, donate or otherwise dispose of such property and the income, principle and proceeds of such property, for any of the purposes set forth herein.
- C. To help stop juvenile crime in the community by providing an alternative to “hanging out” on the streets to the youth of the community.
- D. To do such other things as are incidental to the purposes of the Corporation or necessary or desirable in order to accomplish them.

## **ARTICLE V**

### **LIMITATION**

No part of the net earnings of the Corporation shall inure to the benefit of or be distributed to its Members, Trustees or Officers, but the Corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and

distributions in furtherance of the purposes set forth in Article IV (Purposes) hereof.

## **ARTICLE VI**

### **MEMBERS**

The Corporation shall have Voting Members who shall be elected (and may be removed) by Voting Members and shall have all rights and privileges of members of the Corporation. The Bylaws may provide for Nonvoting Members of one or more classes, who shall be admitted in such a manner and who shall have such rights and privileges as are set forth in the Bylaws, but who shall not have the right to vote. **BYLAWS**

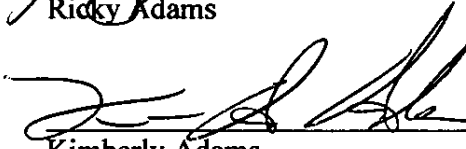

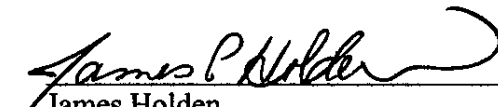
**ARTICLE XI**

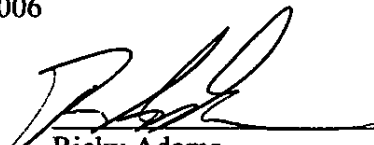
