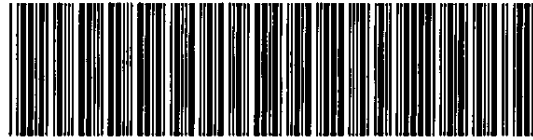

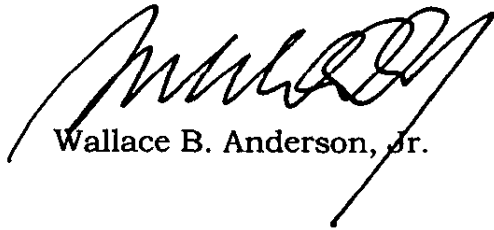

Article One of the Articles of Incorporation of BLACK AMERICANS OF HILLSBOROUGH COUNTY RESOLVING OUR ISSUES AND PLANNING OUR FUTURE, INC. was amended by the Corporation's Board of Directors on Thursday 9 November 2006 at its regular monthly meeting.
