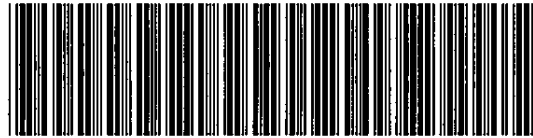

The undersigned, a citizen of the United States, desiring to form a Corporation Not for Profit under the Corporation Not for Profit Law of Florida, Chapter 617, Florida Statutes, certifies and acknowledges:

**ARTICLE I. NAME.**

**ARTICLE III. PURPOSE.**

The Corporation is organized exclusively for charitable, educational, and scientific purposes within the meaning of section 501 (c) (3) of the Internal Revenue Code, as may be amended, including the following:

1. To rescue and transport dogs from high kill shelters, to no kill shelters, pet foster homes and permanent homes across the state of Florida.
2. To promote responsible pet ownership (e.g. spay/neutering, vaccinations, pet ID tags) via educational and volunteer programs.
3. To foster stray and rescued dogs until they are adopted.
4. To assist others in placing homeless, fostered, or unwanted dogs into permanent homes.
5. To fundraise for nonprofit health research in the diseases of PLE/PLN, Addisons Disease, Renal Dysplasia, and IBD as it pertains to the Soft Coated Wheaten Terrier.

**ARTICLE IV. MANNER OF ELECTIONS.**

Elections of new Directors or election of current Directors to a second term will occur as the first item of business at the annual meeting of the Corporation. Directors will be elected by majority vote of the membership. Officers shall be elected for two terms beginning January 1 following an election of the membership.
