AMENDED AND RESTATED

ARTICLES OF INCORPORATION

OF

ESTANCIA AT BOYNTON BEACH HOMEOWNERS ASSOCIATION, INC. (A Florida Corporation Not-For-Profit)

Pursuant to Section 617.1077, Florida Statutes, these Articles of Incorporation of Estancia at Boynton Beach Homeowners Association, Inc., a Florida corporation not-for-profit, which was originally incorporated on June 7, 2006, are hereby amended and restated in their entirety. All amendments included herein have been adopted pursuant to Section 671.1002, Florida Statutes, and there is no discrepancy between the corporation's Articles of Incorporation as heretofore aniended and the provisions of these Amended and Restated Articles other than the inclusion of amendments adopted pursuant to Section 617.1002, Florida Statutes. The Amended and Restated Articles of Incorporation of Estancia of Boynton Beach Homeowners Association, Inc. shall henceforth be as follows:

ARTICLE I DEFINITIONS

The following words and phrases when used in these Articles of Incorporation (unless the context clearly reflects another meaning) shall have the following meanings:

"Articles" means these Articles of Incorporation and any amendments hereto.

"Assessments" means the assessments for which ail "Owners" and "Boat Slip Lot Owners" (both as hereinafter defined) are obligated to the "Association" (as hereinafter defined) and includes "Individual Home Assessments" and "Special Assessments" (as such terms are defined in the Declaration) and any and all other assessments which are levied by the Association in accordance with the "Estancia at Boynton Beach Documents" (as hereinafter defined).

"Association" means Estancia at Boynton Beach Homeowners Association, Inc., a Florida corporation not for profit. The "Association" is NOT a condominium association and is not intended to be governed by Chapter 718, the Condominium Act, Florida Statutes.

"Association Property" means the property more particularly described in Article II of the Declaration.

"Board" means the Board of Directors of the Association.

"Bost Slip Lot" means one (i) of eleven (ii) Bost Slip Lets, set forth on the Plat as Lots 31 through 41.

"Boat Sip Lot Expenses" means expenses for which Boat Sip Lot Owners are liable to the Association as described in the Declaration and in my other Estancia at Boynton Beach Documents, and include, but are not limited to, the costs and expenses incurred by the Association in administering, maintaining or repairing the Boat Slip Lots and dredging the Finger Canal in order to maintain navigability for the Vessels occupying the Boat Slip Lots; provided, however, that the Association shall not assess Boat Slip Lot Owners for the cost of dredging the Finger Canal to maintain navigability without first obtaining the consent of two-thirds (2/3) of the Boat Slip Lot Owners.

"Boat Slip Lot Owner" means the owner of a Boat Slip Lot within Estancia at Boynton Beach. A Boat Slip Lot.Owner must own a Home within Estancia at Boynton Beach.

"Bylaws" mean the Bylaws of the Association and any amendments thereto.

"County" means Palm Beach County, Florida.

"Declarant" means HHC BOYNTON, LLC, a Florida limited liability company, and any successor or assign thereof to which either entity specifically assigns all or part of the rights of Declarant under the Declaration by an express written assignment, whether recorded in the Public Records of the County or not. The written assignment may give notice as to which rights of Declarant are to be exercised and as to which portion of the Property. In any event, any subsequent declarant shall not be liable for any default or obligations incurred by any prior declarant, except as may be expressly assumed by the subsequent declarant.

"Declaration" means the Declaration of Covenants, Restrictions and Easements for Estancia at Boynton Beach, which is to be recorded amongst the Public Records of the County, and any amendments thereto.

"Director" mesas a member of the Board.

"Estancia at Boynton Beach" means that planned residential development located in the County, which will consist of the land set forth in Exhibit "A" of the Declaration and may be expanded or contracted by the recording of one or more Supplemental Declarations, and which initially is intended to comprise thirty (30) Homes contained in six (6) buildings, eleven (11) Boat Slip Lots, and the Association Property.

"Estancia at Boynton Beach Documents" means in the aggregate the Declaration, the Articles and the Bylaws, and all of the instruments and documents referred to therein including, but not limited to, any amendment(s) thereto.

"HOA Act" means the Homeowners' Association Act, Chapter 720, Florida Statutes, as amended through the date of the recording of the Declaration among the Public Records of the County.

"Home" means an attached residential dwelling unit constructed within Estancia at Boynton Beach, which is designed and intended for use and occupancy as a single-family

residence.

"Member" means a member of the Association,

"Operating Expenses" means the expenses for which Owners are liable to the Association as described in the Declaration and in any other Estancia at Boymon Beach Occuments and include, but are not limited to, the cests and expenses incurred by the Association in administering, operating, maintaining, financing or repairing, but not reconstructing, replacing or improving, the Association Property and improvements thereon and all costs and expenses incurred by the Association in carrying out its powers and daties berounder or under any other Estancia at Boynton Beach Documents

"Owner" means the record owner, whether one or more persons or entities, of the fee simple title to any Home within Estancia at Boymon Beach, and includes Declarant for ax long as Declarant owns fee simple title to a Home, but excluding therefrom those having such interest as security for the performance of an obligation.

Unless otherwise defined herein, the terms defined in the Declaration are incorporated herein by reference and shall appear in initial capital letters each time such terms appear in these Articles.

ARTICLE II NAME

The name of this corporation shall be ESTANCIA AT BOYNTON BEACH HOMEOWNERS ASSOCIATION, INC., a Fiorida corporation not for profit, whose principal and mailing address is 601 North Congress Avenue, Suite 114, Delray Beach, Florida 33445.

ARTICLE III PURPOSES

The purpose for which the Association is organized is to take title to, operate, administer, manage, lease and maintain the Association Property in accordance with the terms of, and purposes set forth in, the Estancia at Boynton Beach Documents and to carry out the covenants and enforce the provisions of the Estancia at Boynton Beach Documents.

ARTICLE IY POWERS

The Association shall have the following powers and shall be governed by the following provisions:

- A. The Association shall have all of the common law and statutory powers of a corporation not for profit.
- B. The Association shall have all of the powers granted to the Association in the Estancia at Boynton Beach Documents. All of the provisions of the Declaration and Bylaws,

which grant powers to the Association, are incorporated into these Articles.

- C. The Association shall have all of the powers reasonably necessary to implement the purposes of the Association including, but not limited to, the following:
- 1. To perform any act required or contemplated by it under the Estancia at Boyaton Beach Documents.
- To make, establish, amend and enforce reasonable rules and regulations governing the use of the Association Property.
- 3. To make, levy, and collect Assessments for the purpose of obtaining funds from its Members to pay the Operating Expenses, the Boat Slip Lot Expenses, and other costs defined in the Declaration, and costs of collection, and to use and expend the proceeds of Assessments in the exercise of the powers and duties of the Association.
- 4. To own, maintain, repair, replace, operate and convey the Association Property in accordance with the Estancia at Boynton Beach Documents.
- 5. To enforce by legal means the obligations of the Members and the provisions of the Estancia at Boynton Beach Documents.
- 6. To employ personnel, retain independent contractors and professional personnel, and enter into service contracts to provide for the maintenance, operation, administration and management of the Association Property and to enter into any other agreements consistent with the purposes of the Association, including, but not limited to, agreements with respect to professional management of the Association Property and to delegate to such professional manager certain powers and deties of the Association.
- 7. To enter into the Declaration and any amendments thereto and instruments referred to therein.
- 8. To provide, to the extent deemed necessary by the Board, any and all services and do any and all things which are incidental to or in furtherance of things listed above or to carry out the Association mandate to keep and maintain Estancia at Boynton Beach in a proper and aesthetically pleasing condition and to provide the Owners with services, amenities, controls and enforcement which will enhance the quality of life at Estancia at Boynton Beach.
- 9. Notwithstanding anything contained herein to the contrary, the Association shall be required to obtain the approval of three-fourths (3/4) of all Members (at a duly called meeting of the Members at which a quorum is present) prior to the engagement of legal counsel by the Association for the purpose of suing, or making, preparing or investigating any lawsuit, or commencing any lawsuit other than for the following purposes:

- (a) collection of Assessments;
- (b) collection of other charges that Owners are obligated to pay pursuant to the Estancia at Boyoton Beach Documents;
- (a) enforcement of any applicable use and occupancy restrictions contained in the Estancia at Boynton Beach Decuments:
- (d) dealing with an emergency when waiting to obtain the approval of the Members creates a substantial risk of breparable injury to the Association Property or to Member(s) (the imminent expiration of a statute of limitations shall not be deemed an emergency obviating the need for the requisite vote of three-featable (3/4) of the Members); or
 - (c) filing a compulsory counterelains.
- 10. To borrow money and to obtain such linearing as is necessary to maintain, repair and replace the Association Property in accordance with the Declaration and the Estancia at Boynton Beach Deciments and as security for any such loan, to collaterally assign the Association's right to collect and enforce Assessments levied for the purpose of repaying any such loan.

ARTICLE Y MEMBERS AND VOTING

The qualification of Members of the Association, the manner of their admission to membership, the manner of the termination of such membership and the manner of voting by Members shall be us follows:

- A. Until such time as the first deed of conveyance of a Home from Declarant to an Owner is recorded amongst the Public Records ("First Conveyance"), the membership of the Association shall be comprised solely of Declarant. Until the First Conveyance, Declarant shall be entitled to east the one (1) and only vote on all matters requiring a vote of the membership.
- B. Upon the First Conveyance, Declarant shall be a Member as to each of the remaining Homes until each such Home is conveyed to another Owner and thereupon and thereafter each and every Owner, including Declarant as to Homes owned by Declarant, shall be a Member and exercise all of the rights and privileges of a Member
- C. Membership in the Association for Owners other than Declarant shall be established by the acquisition of expership of the simple title to a Home as evidenced by the recording of an instrument of conveyance amongst the Poblic Records. Where title to a Home is acquired by conveyance from a party other than Declarant by means of sale, gift, inheritance, devise, judicial decree or otherwise, the person, persons or entity thereby acquiring such Home shall not be a Member unless or unit such Owner shall deliver a true copy of a deed or other instrument of acquisition of title to the Association. Except where expressly provided for in these Amended and Restated Articles, the Bylaws, or the Declaranon, a Boat Slip Lot Owner

shall not have any additional votes or voting rights on matters affecting the Association on account of owing a Boat Slip Lot.

- D. The Association shall have two (2) classes of voting membership:
- ¹ "Class A Members" shall be all Members, with the exception of Declarant white Declarant is a Class B Member, each of whom shall be entitled to one (1) voic for each Home owned.
- 2. "Class B Members" shall be Declarant, who shall be emitted to three (3) times the total number of votes of the Class A Members, plus one (1). Class B membership shall cease and be converted to Class A membership upon the earlier to occur of the following events ("Turnover Date"):
- (i) Three (3) months after the conveyance of ninety percent (90%) of the Homes by Declarant, as evidenced by the recording of instruments of conveyance of such Homes amongst the Public Records; or
- (ii) At such time as Declarant shall designate in writing to the Association.
- On the Turnover Date, Class A Members, including Declarant, shall assume control of the Association and elect not less than a majority of the Board.
- E. The designation of different classes of membership are for purposes of establishing the number of votes applicable to certain Homes, and nothing herein shall be deemed to require voting solely by an individual class on any matter which requires the vote of Members, unless otherwise specifically set forth in the Estancia at Boynton Beach Documents.
- F. No Member may assign, hypothecase or transfer in any manner his/her membership in the Association except as an appurtenance to his/her Home.
- G. Any Member who conveys or loses title to a Home by sale, gift, devise, bequest, judicial decree or otherwise shall, immediately upon such conveyance or loss of title, no longer he a Member with respect to such Home and shall lose all rights and privileges of a Member resulting from ownership of such Home.
- H. There shall be only one (1) vote for each Home, except for the Class B Members as set forth herein. If there is more than one Member with respect to a Home as a result of the fee interest in such Home being held by more than one person, such Members collectively shall be entitled to only one (1) vote. The vote of the Owners of a Home owned by more than one natural person, or by a corporation or other legal entity, shall be east by the person named in a certificate signed by all of the Owners of the Home or, if appropriate, by properly designated efficers, partners or principals of the respective legal entity ("Voting Member"), and filed with the Secretary of the Association, and such certificate shall be valid until revoked by a subsequent certificate. If such a certificate is not filed with the Secretary of the Association, the vote of such

Home shall not be considered for a quorum or for any other purpose.

Noiwithstanding the foregoing provisions, whenever any Home is owned by a husband and wife, they may, but shall not be required to, designate a Voting Member. In the event a certificate designating a Voting Member is not filed by the husband and wife, the following provisions shall govern their right to vote:

- When both are present at a meeting, each shall be regarded as the agent and proxy of the other for purposes of casting the vote for each Home owned by them. In the event they are unable to concur in their decision upon any topic requiring a vote, they shall less their right to vote on that topic at that meeting, but shall count for purposes of establishing a quorum.
- 2. When only one (1) spouse is present at a meeting, the person present may cast the Home vote without establishing the concurrence of the other spouse, absent any prior written notice to the contrary by the other spouse. In the event of prior written notice to the contrary to the Association by the other spouse, the vote of said Home shall not be considered, but shall count for purposes of establishing a quorum.
- 3. When neither spouse is present, the person designated in a "Proxy" (as defined in the Bylaws) signed by either spouse may east the Home vote, when voting by Proxy is allowed, absent any prior written notice to the contrary to the Association by the other spouse or the designation of a different Proxy by the other spouse. In the event of prior written notice to the contrary to the Association or the designation of a different Proxy by the other spouse, the vote of said Home shall not be considered, but shall count for purposes of establishing a quorum.
- A quorum shall consist of persons entitled to east at least forty percent (40%) of the total number of votes of the Members.
- J. Except as set forth in these Amended and Restated Arricles, the Bylaws, and the Declaration, the Owner of a Boat Slip Let shall not be entitled to a separate vote on matters affecting the Members and the Association on account of any ownership of a Boat Slip Lot. Notwithstanding the foregoing, the consent of two-thirds (2/3) of the eleven (11) Boat Slip Lot Owners shall be required prior to assessing the Boat Slip Lot Owners for the cost of dredging the Finger Canal in order to maintain navigability.

ARTICLE VI

The term for which this Association is to exist shall be perpetual. In the event of dissolution of the Association (unless same is reinstated), other than incident to a merger or consolidation, all of the assets of the Association shall be conveyed to a similar homeowners association or a public agency having a similar purpose, but in the case of the surface water management system, to an appropriate agency of local government (in the event such agency of local government does not accept such conveyance of the surface water management system then, in such case, the surface water management system shall be conveyed to a similar non-

profit corporation), or any Member may petition the appropriate orient court of the State of Florida for the appointment of a receiver to manage the affairs of the dissolved Association and its properties in the place and stead of the dissolved Association and its make such provisions as may be necessary for the continued management of the affairs of the dissolved Association and its properties.

ARTICLE YII OFFICERS

The affairs of the Association shall be managed by the President of the Association, assisted by the Vice-President(s), Secretary and Treasurer, and, if any, by the Assistant Secretary(ies) and Assistant Treasurer(s), subject to the directions of the Board. Except for officers elected prior to the Tornover Date, officers must be Members, or the parents, children or spouses of Members.

The Board shall elect the President, Secretary, and Treasurer, and as many Vice-Presidents, Assistant Secretaries, and Assistant Treasurers as the Board shall, from time to time, determine. The President shall be elected from amongst the membership of the Board, but to other officer need be a Director. The same person may hold two (2) offices, the duties of which are not incompatible, provided, however, the office of President and a Vice-President shall not be held by the same person, nor shall the office of President and Secretary or Assistant Secretary be held by the same person.

In the event that any earlies on trust shall own a Home, and said entity or trust is thereby a Member of the Association, for so long as said entity or trust is a Member of the Association, then any designer of said entity or trust shall be eligible to serve as an officer of the Association.

ARTICLE VIU FIRST OFFICERS

The names of the officers who are to serve until the first election of officers by the Board are as follows:

ARTICLE IX BOARD OF DIRECTORS

A. The number of Directors on the first Board of Directors of the Association ("First Board") and the "Initial Elected Board" (as hereinafter defined) shall be three (3). The number of Directors elected by the Members subsequent to the "Declarant's Resignation Event" (as hereinafter defined) shall be not less than three (3) nor more than five (5), as the Board shall from time to time determine prior to each meeting at which Directors are to be elected. Except for Declarant-appointed Directors, Directors must be Members, or the parents, children or

spouses of Members, or, in the case of an entity or trust which is a Member, then so long as said entity or trust is a Member of the Association, any designee of said entity or trust shall be eligible to serve as a Director of the Association. There shall be only one (1) vote for each Director.

Declarant reserves the right to replace and/or designate and elect successor Directors to serve on the First Board for so long as the First Board is to serve, as hereinafter provided.

- C. Declarant presently intends that Estancia, when ultimately developed, will contain thirty (30) Homes. Notwithstanding the foregoing, Declarant has reserved the right in the Declaration to modify its plan of development for Estancia and to add land to Estancia and, therefore, the total number of Homes within Estancia may refer to a number greater than thirty (30). The revised number of Homes added to Estancia will be set forth in a Supplemental Declaration recorded in the County if additional land is added to Estancia. Upon the Turnover Dute, the Members (including Declarant) shall be entitled to elect all the Directors. The election shall occur at a special meeting of the membership to be called by the Board for such purpose ("Initial Election Meeting"). The First Board shall serve until the Initial Election Meeting.
- D. The Board shall continue to be so designated and elected, at each subsequent "Annual Members' Meeting" (as such term is defined in the Bylaws).
- E. A Director (other than a Declarant-appointed Director) may be removed from office upon the affirmative vote of a majority of the veting interests of Members for any reason deemed to be in the best interests of the Members. A meeting of the Members to so remove a Director (other than a Declarant-appointed Director) shall be held upon the written request of ten percent (10%) of the Members. Any such recall shall be effected, and a recall election shall be held, if applicable, as provided in the HOA Act.
- F. The Initial Election Meeting shall be called by the Association, through the Board, within sixty (60) days after the Members other than Declarant, are entitled to elect a majority of Directors as provided in Paragraph D hereof. A notice of meeting shall be forwarded to all Members in accordance with the Bylaws; provided, however, that the Members shall be

given as least fourteen (14) days' notice of such meeting. The notice shall also specify the number of Directors which shall be elected by the Members.

- G. At the Initial Election Meeting, a "staggered" term of office of the Board shall be created as follows:
- a number equal to fifty percent (50%) of the total number of Directors rounded to the nearest whole number is the number of Directors whose term of effice shall be established at two (2) years and the Directors serving for a two (2) year term will be the Directors receiving the most votes at the needing; and
- the remaining Directors' terms of office shall be established at one (1) year.

At each Annual Members' Meeting thereafter, as many Directors of the Association shall be elected as there are Directors whose regular term of office expires at such time, and the term of office of the Directors so elected shall be for two (2) years, expiring when their successors are duly elected and qualified.

H. The resignation of a Director who has been designated by Declarant or the resignation of an officer of the Association who has been elected by the First Board shall be deemed to remise, release, acquit, satisfy and forever discharge such officer or Director of and from any and all manner of action(s), cause(s) of action, satisfy dues, sums of money, accounts, reckonings, bonds, bills, specialties, covenants, contracts, controversies, agreements, promises, variances, trespasses, damages, judgments, executions, claims and demands whatsoever, in law or in equity, which the Association or the Members had, now have or will have or which any personal representative, successor, heir or assign of the Association or the Members hereafter can, shall or may have against said officer or Director for, upon or by reason of any matter, cause or thing whatsoever from the beginning of the world to the day of such resignation, except for such Director's or officer's willful misconduct or gross negligence.

ARTICLE X INDEMNIFICATION

Each and every Director and officer of the Association shall be indemnified by the Association against all costs, expenses and liabilities, including attorney and paralegal fees at all trial and appellate levels and post-judgment proceedings, reasonably incurred by or imposed upon him/her in connection with any negotiation, proceeding, arbitration, litigation or settlement in which he/she becomes involved by reason of his/her being or having been a Director or officer of the Association, and the foregoing provision for indemnification shall apply whether or not such person is a Director or officer at the time such cost, expense or liability is incurred. Notwithstanding the above, in the event of any such settlement, the indemnification provisions provided in this Article XI shall not be automatic and shall apply only when the Board approves such settlement and reimbursement for the costs and expenses of such settlement as being in the best interest of the Association, and in the event a Director or officer admits that he/she is or is adjudged guilty of willful misfeasance or malfeasance in the performance of his/her duties, the

indemnification provisions of this Article XI shall not apply. The foregoing right of indemnification provided in this Article XI shall be in addition to and not exclusive of any and all rights of indemnification to which a Director or officer of the Association may be entitled under statute or common law.

ARTICLE X BYLAWS

The Bylaws shall be adopted by the First Board, and thereafter may be altered, amended or respinded in the manner provided for in the Bylaws. In the event of any conflict between the provisions of these Articles and the provisions of the Bylaws, the provisions of these Articles shall control.

ARTICLE XII AMENDMENTS

- A. Prior to the First Conveyance, these Articles may be amended only by an instrument in writing signed by the incorporator of these Articles and filed in the Office of the Secretary of State of the State of Florida.
- B After the First Conveyance, and prior to the Turnover Date, these Articles may be amended solely by a majority vote of the Board, without the prior written consent of the Members, at a duly called meeting of the Board.
 - C. After the Turnover Date, these Articles may be amended in the following manner:
- 1. (a) The Board shall adopt a resolution setting forth the proposed amendment and directing that it be submitted to a vote at a meeting of the Members, which may be at either the Annual Members' Meeting or a special meeting. Any number of proposed amendments may be submitted to the Members and voted upon by them at one meeting.
- (b) Written notice setting forth the proposed amendment or a summary of the changes to be effected thereby shall be given to each Member within the time and in the manner provided in the Bylaws for the giving of notice of meetings.
- (c) At such meeting, a vote of the Members shall be taken on the proposed amendment(s). The proposed amendment(s) shall be adopted upon receiving the affirmative vote of a majority of the total voting interests present at such meeting.
- 2. An amendment may be adopted by a written statement (in lieu of a meeting) signed by all Members and all members of the Board setting forth their intention that an amendment to the Articles be adopted:
- D. These Articles may not be amended without the written consent of a majority of the members of the Board.

- E. Notwithstending any provisions of this Article XIII to the contrary, these Articles shall not be amended in any manner which shall prejudice the rights of: (i) Deciarant, without the prior written consent thereto by Declarant, for so long as Deciarant holds either a leasehold interest in or title to at least one (1) Horne; and (ii) any "Institutional Mortgagee" (as such term is defined in the Deciaration) without the prior written consent of such Institutional Mortgagee.
- P. Notwithstanding the foregoing provisions of this Article XIII, no amendment to these Articles shall be adopted which shall abridge, amend or alter the rights of Declarant hereunder including, but not limited to. Declarant's right to designate and select members of the First Board or otherwise designate and select Directors as provided in Article X hereof nor shall any amendment be adopted or become effective without the prior written consent of Declarant.
- G. Any instrument amending these Articles shall identify the particular article or articles being amended and shall provide a reasonable method to identify the amendment being made. A certified copy of each such amendment shall be estached to any certified copy of these Articles, and a copy of each amendment certified by the Secretary of State shall be recorded amongst the Public Records of the County.
