KREWE OF SOUTH SHORE MARAUDERS FOUNDATION, INC.

Under the provisions of F.S. 617.1001, this corporation adopts the following articles of amendment to its articles of incorporation:

FIRST: Amendment adopted to add a new Article IX:

Article IX

This Foundation is organized exclusively for charitable, religious, educational, and scientific purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501 (c) (3) of the Internal Revenue Code, of the corresponding section of any future federal tax code.

The date of the amendment's adoption: January 9, 2007.

SECOND: Amendment adopted to add a new Article X:

Article X

No part of the net earnings of this Foundation shall inure to the benefit of, or be distributable to its members, board of directors, officers, or other private persons, except that this Foundation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in the purpose clause hereof. No substantial part of the activities of this Foundation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and this Foundation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of any candidate for public office. Notwithstanding any other provision of

this document, this Foundation shall not carry on any other activities not permitted to be carried on (a) by an organization exempt from federal income tax under section 501 (c) (3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or by an organization, contributions to which are deductible under section 170 (c) (2) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

The date of the amendment's adoption: January 9, 2007.

THIRD: Amendment adopted to add a new Article XI:

Article XI

Upon the dissolution of this Foundation, all assets shall be distributed for one or more exempt purposes within the meaning of section 501 (c) (3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not disposed of shall be disposed of by the Circuit Court in the county in which the principal office of the Foundation is then located, exclusively for such purposes or to such organizations or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.

The date of the amendment's adoption: January 9, 2007.

FOURTH: Adoption of Amendment:

The amendments were approved by the members on January 9, 2007. The number of votes cast for the amendments was sufficient for approval.
