

ARTICLES OF INCORPORATION  
OF  
FAMILY TREE CENTER, INC.

ARTICLE I.

The name and address of this principal corporation is Family Tree Center, Inc. 4821 Sable Pine Circle, Unit B-2 West Palm Beach, Florida 33417. The corporation is organized pursuant to the Florida Nonprofit Corporation Code.

ARTICLE II.

This corporation is a nonprofit public benefit corporation and is not organized for the private gain of any person. The mission of The Family Tree Center is to provide specialized family-based services for all residents of Palm Beach County. The center offers a variety of therapeutic support services that strengthen, empower and if needed, help reunify families through its comprehensive treatment team. At-risk assessments will be conducted to determine if a client would be an appropriate candidate for enrollment in our program. The center will also work with the court, law enforcement, and human services systems, offering information or to the general community. The Family Tree Center uses holistic approach, working with the entire family to identify their needs and assist them in accessing the appropriate resources.

ARTICLE III.

The purpose of which the Family Tree Center, Inc. is organized, is to maintain the integrity of the family. This involves giving parents the tools to reduce or eliminate risk factors that places family members in imminent risk while helping them to become self-sufficient.

ARTICLE IV.

The address of the registered office is Family Tree Center, Inc. 4821 Sable Pine Circle, Unit B-2 West Palm Beach, Florida 33417, and the names of the registered agents of the corporation shall be:

## ARTICLE V

(A) This corporation is organized and operated exclusively for the innovative approach to working with families that have been identified as being in need of immediate intervention. A team consisting of a professional counselor and a family support worker will provide services to a maximum of six families per counselor at a time, with a minimum of two visits per week. The program is time-limited to three months and may be extended an additional 30 days for special circumstances. During the time a family is receiving services, our staff will be on call 24-hours, to deal with any crisis that may arise. There will also be a year tracking with the family after their case is closed. Tracking will be every 2 months for one year.

(B) Notwithstanding any other provision of the Articles, the corporation shall not carry on any other activities not permitted to carry on (1) by a corporation exempt from federal income tax under Section 501 (C) (3) of the Internal Revenue Code or (2) by a corporation contributions to which are deductible under Section 170 (C) (2) of the Internal Revenue Code.
