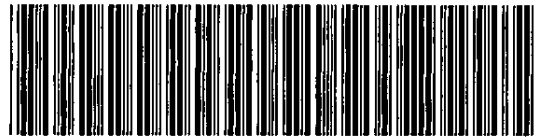

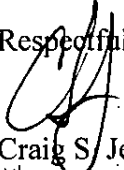
This is a letter and enclosed documents are in response to your above-referenced number. My apology for not preparing and forwarding the incorporations documents in the proper manner.

## ARTICLES OF INCORPORATION

In Compliance with Chapter 617, F.S., (Not for Profit)  
International Underwater Cave Rescue and Recovery Inc.

### ARTICLE I

The name of the corporation shall be the: INTERNATIONAL UNDERWATER CAVE RESCUE AND RECOVERY, Inc. herein after the IUCRR

### ARTICLE II

The principal place of business and mailing address of this corporation shall be:  
International Underwater Cave Rescue and Recovery Inc.  
2826 Shoal Creek Village Drive  
Lakeland, Florida 33803

### ARTICLE III

The purpose for which the corporation is organized is to support all Public Safety Agencies in the rescue and/or recovery of victims in an underwater environment (with an overhead obstruction such as caves, caverns, mine shafts, etc.). Said corporation is organized exclusively for charitable, educational, and scientific purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

The International Underwater Cave Rescue and Recovery Inc. shall provide its services to Federal, State and local Law Enforcement and Public Safety organizations within the United States of America at no cost to that agency. The International Underwater Cave Rescue and Recovery Inc. will on a case-by-case basis assist such agencies of other countries upon receipt of an official request to the International Underwater Cave Rescue and Recovery Inc. within appropriate channels. Policies of the International Underwater Cave Rescue and Recovery Inc. will be controlled by the Law Enforcement Advisory Board (LEAB) whose members shall be made up of active or retired Law Enforcement or Public Safety Personnel.

In the event of the dissolution of the International Underwater Cave Rescue and Recovery Inc., its assets shall be equally divided and distributed to the National Association of Cave Diving and to the Cave Diving Section of the National Speleological Society, both Florida not for profit 501c3 corporations.

### ARTICLE IV MANNER OF ELECTION

The manner in which the directors are elected or appointed shall be determined <sup>(as stated</sup> ~~by a Charter Board of Directors~~ <sup>in the By-laws)</sup>. The operation of the International Underwater Cave Rescue and Recovery Inc. shall be conducted by its officers who shall be elected by the Board of Governors as outlined in the corporate by-laws.

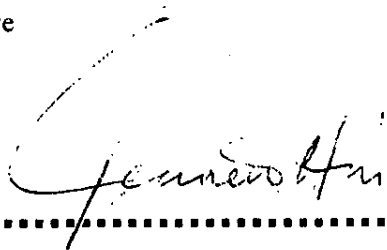
