

### ARTICLES OF INCORPORATION FOR ADAMS PLACE CONDOMINIUM ASSOCIATION, INC.

## ARTICLE 13 AMENDMENTS

By the Board of Directors. Notwithstanding any other provision of this Article 13, the Board of Directors shall have the authority to amend these Articles of Incorporation for the sole purpose of modifying the name of the Condominium Property and corporate entity by a majority vote of those Directors present and voting at a duly noticed meeting of the Board. This provision shall not affect the authority of Unit Owners to amend any portion of these Articles of Incorporation pursuant to Article 13.
