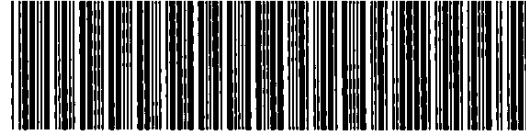

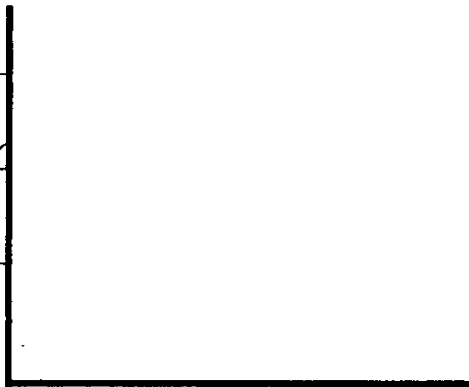

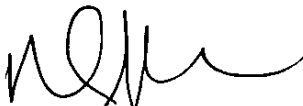
Pursuant to the provisions of Section 617.1006, Florida Statutes, Florida Civil Justice Association, Inc., (Charter Number N06000006384), a Florida Not for Profit Corporation, hereby adopts the following amendment to Article I of its Articles of Incorporation to reflect a name change. Such article shall hereafter read:

NAME

The name of the Corporation shall be "Florida Association for Justice, Inc."
