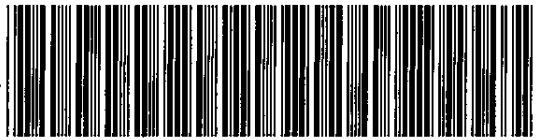

**ARTICLES OF INCORPORATION  
OF THE  
BAYSIDE INSTRUMENTAL MUSIC BOOSTER'S ASSOCIATION, Inc.**

**ARTICLE I: NAME**

Section 1 – The name of the Corporation shall be known as the Bayside Instrumental Music Booster's Association, Incorporated.

Section 2 – The Bayside Instrumental Music Booster Association shall be a 501(c)(3) non-profit organization.

**ARTICLE II: PRINCIPAL OFFICE**

The principal place of business of the Bayside Instrumental Music Booster's Association, Incorporated is Bayside High School, Palm Bay, Florida. The mailing address shall be: Ellen Shea, 574 De Leon Court, NW, Palm Bay, Florida 32907.

**ARTICLE III: PURPOSE**

Section 1 – To promote activities of interest to the students of the programs falling under the direction of the Bayside High School Director(s) of Instrumental Music.

Section 2 – To promote and encourage the participation in and the understanding of instrumental music programs among the students of Bayside High School.

Section 3 – To finance or partially finance those activities, uniforms, instruments and other equipment and supplies not furnished by Bayside High School and/or the Brevard County School District.

Section 4 – To organize and promote the efforts of volunteers for the benefit of the Bayside High School Instrumental Music Program.

**ARTICLE IV: MANNER OF ELECTIONS**

Section 1 – The leadership of the Bayside Instrumental Music Booster's Association, Incorporated, execution of its programs, and management of finances are vested in a Board of Directors. The Board shall be composed of the elected members of the Bayside Instrumental Music Booster's Association, Incorporated, the Student Representative, the Auxiliary Representative(s), and the Band Director(s). Each position shall have one vote for any or all decisions made by the Board of Directors.

Section 2 – The Chair of the Board of Directors, Vice Chair, Treasurer of the General Fund, Treasurer of Student Accounts, Chairs of Committees, and Secretary shall be elected by the General Membership and shall constitute the elected members of the Bayside Instrumental Music Booster's Association, Incorporated. Only an individual who is the parent or legal guardian of a student enrolled in one or more of the performing arts programs of the Bayside High School Instrumental Music Department may serve as an elected officer of the Bayside Instrumental Music Booster's Association, Incorporated.

Section 3 – The President shall appoint a Nominating Committee no later than 1 March. Candidate names for elected positions shall be announced by 1 April, with elections no later than the April General Membership meeting, at which time additional nominations may be made from the floor. The Nominating Committee shall consist of not less than three (3) people, including not more than one (1) from the Board of Directors.

Section 4 – Following the election of the new Board of Directors in April, the Board of Director's meeting(s) in May shall be a combined meeting(s) of outgoing and incoming Boards.

Section 5 – The term of office shall be from 1 June to 31 May. This shall constitute the fiscal year.

Section 6 – If an elected officer resigns from the Bayside Instrumental Music Booster's Association, Incorporated, the President shall nominate, and the Board of Directors shall confirm, an individual to serve the remaining term.

Section 7 – If any member of the Bayside Instrumental Music Booster's Association, Incorporated, is determined by the Board of Directors to be not fulfilling the requirements of or abusing the privileges of their position, this member may be penalized or removed from office with a two-thirds ( $2/3^{\text{rds}}$ ) vote of the entire Board of Directors.


