## FIRST AMENDMENT TO ARTICLES OF INCORPORATION

## Article 13 of the Articles of Incorporation are hereby amended to read as follows:

"13. Amendments. Until termination of the Class "B" membership, Declarant may unilaterally amend these Articles for any purpose. After termination of the Class "B" Control-Period, a Amendments to these Articles may be adopted upon a resolution of the Board and the affirmative vote or written consent of Members representing at least 67% seventy-five percent (75%) of those Members, present in person or by proxy, provided at least eighty-five (85) Members cast a votethe Class "A" votes in the Association. No amendment may be in conflict with the Declaration."
