

ARTICLE I NAME

The name of the corporation shall be:

ARTICLE II PRINCIPAL OFFICE

The principal place of business and mailing address of this corporation shall be: 2501 North Orange Ave., Suite 214, Orlando, Fl 32804

ARTICLE III PURPOSE

The purpose for which the corporation is organized is:

- A. To unite urologic nurses and allied health professionals for the purpose of maintaining a Chapter dedicated to the promotion of the highest professional standards for the care of the urological patient.
- B. To study, discuss and exchange information, experiences, and ideas in the field of urology.
- C. To be the unifying organization in its membership area for those providing patients with urologic care and education.
- D. To provide diverse educational opportunities for its Chapter members.
- F. To advance the urological and professional knowledge of CFC members and the community at large with an interest in urology.
- G. To hold meetings at intervals for the advancement of the purposes of this Chapter.
- H. To provide networking opportunities for CFC members, including working to develop a speakers' bureau.
- I. To cooperate lawfully with other professional associations, hospitals, universities, industries, technical societies, research organizations, and governmental agencies in matters affecting the foregoing purposes of this Chapter.

ARTICLE IV MANNER OF ELECTION

The manner in which the directors are elected or appointed:

- Section 1. Officers of the Board. All Board members shall be elected or appointed as provided in these bylaws. CFC officers are President, Vice-President, Secretary, Treasurer, Immediate, Past-President, and two (2) Members-at-Large. Eligibility for office shall be dependent upon active membership in SUNA for one (1) year preceding nomination.
- Section 2. Election of Officers. The Nominating Committee or, in the absence of a formal Nominating Committee, the CFC Board, will submit a list of candidates for each position up for election. Prior consent of nominees and their willingness to serve must be obtained prior to submission. At least 30 days prior to the close of voting, each member in good standing must be sent a ballot via email or regular mail.
- Section 3. Terms of Office. All terms of office will be for two (2) years, and Board positions will be elected in a staggered pattern to avoid complete turnover of the Board and preserve continuity. The groupings are as follows: The President, Secretary and one (1) Member-at-Large will be elected in years alternating with the election of Vice-President, Treasurer and one (1) Member-at-Large.
 - A. The current President and Secretary and one (1) Member-at-Large will be elected in odd numbered years.
 - B. The Vice-President, Treasurer and one (1) Member-at-Large will be elected in even numbered years.
 - C. No officer shall serve more than two (2) consecutive terms in the same office.
 - D. The term of office shall begin at the adjournment of the meeting at which they have been elected.
