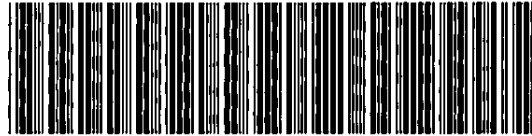

ARTICLES I
CORPORATE NAME

The name of this corporation is GRACE MINISTRIES OF SHABACH INC.

ARTICLE II
CORPORATE ADDRESS

The principle place of business and mailing address of the corporation's registered office shall be 3127 Franklin St. Jacksonville, FL 32206.

ARTICLE III
GENERAL AND SPECIFIC PURPOSES

The primary purposes for which this corporation is formed are:

- This is a nonprofit corporation, organized for the general educational, religious, and charitable purposes pursuant to the Florida Corporation Not for Profit Law set forth in Section 617 of the Florida Statutes.
- To provide Biblical teachings of Christian morals and ethics, with demonstrations of beliefs through weekly gatherings and meetings.
- To operate in any other manner in purposes that will qualify it as an exempt organization under section 501 (c) (3) of the Internal Revenue Code of 1954, amendment, or any subsequent federal tax law under Internal Revenue Code.

To invest in the corporation sufficient power and authority in all matters so that the corporation may have competent legal representative in all matter, property, rights, and other interest in the said corporation.

ARTICLE IV
CORPORATE POWERS

Corporate powers of this corporation are as provided in Chapter 617, Florida Statutes, and unless otherwise limited by the bylaws.

ARTICLE V
REGISTERED AGENT AND OFFICE

ARTICLE VI INCORPORATER

IX DURATION

The term of existence of the corporation is perpetual.

X MEMBERSHIP

This corporation shall operate on a non-stock basis; with one class of membership described bellow:

To be known, as the Broad of Members shall consist of five individuals: The President of Grace Ministries of Shabach Inc, Vice President, Treasurer, Secretary, and Director.

XI DISSOLUTION

Upon dissolution of the Corporation, remaining assets shall be distributed to a non-profit organization that operates with purposes similar to this corporation.

XIII BOARD OF DIRECTORS


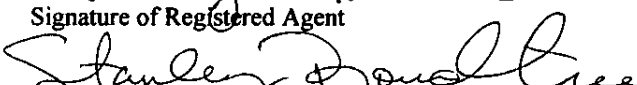
