# ARTICLES OF INCORPORATION SEAMILES CHILDREN'S CHARITABLE FOUNDATION, INC.

In Compliance with Chapter 617, F.S., the undersigned, being a natural person, does hereby act as an incorporator in adopting and filing the following articles of incorporation for the purpose of organizing a not-for-profit corporation.

#### ARTICLE I

The name of the corporation is SeaMiles Children's Charitable Foundation, Inc. (hereinafter, the "Corporation").

#### ARTICLE II

The street address of the principal office of the Corporation is 3020 Northeast 32nd Northeast 3

#### ARTICLE III

The Corporation is organized and operated exclusively for charitable purposes and endeavors within the meaning of Section 501 of the Internal Revenue Code of 1988, as amended (hereinafter, the "Code"), primarily focusing on disabled, disadvantaged, or at-risk children. Notwithstanding any other provisions of these Articles, the Corporation shall not carry on any activities not permitted to be carried on (i) by a corporation exempt from federal income tax under Section 501(c)(3) of the Code, or (ii) by a corporation contributions to which are deductible under Section 170(a) of the Code as being to an organization referred to in Section 170(c)(2) of the Code. The Corporation is not organized, and shall not be operated for, pecuniary gain of profit. No part of the property or net earnings of the Corporation shall inure to the benefit of, or be distributable to its directors or officers, or other private persons, except that the Corporation shall be organized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth herein.

#### ARTICLE IV

The Corporation shall be governed by a Board of Directors. The members of the initial Board of Directors are identified in Article V below. All future Directors shall be elected or appointed by a vote of a majority of the incumbent members of the Board of Directors at the time of said vote and according to the procedures described in the Corporation's By-Laws. Notwithstanding anything to the contrary in these Articles or the Corporation's By-Laws, the Chairman of the Board of Corporate Properties Limited or his/her designee shall serve as the Chairman, as well as a member, of the Board of Directors of the Corporation unless otherwise determined by a majority vote of the Board of Directors of the Corporation.
