The undersigned subscriber, a natural person competent to contract, hereby presents these Amended And Restated Articles of Incorporation for a corporation not for profit, under the laws of the State of Florida.

ARTICLE I

CORPORATE NAME

The name of this corporation is **JACKSONVILLE PHYSICIANS FOR AFGHAN MEDICAL RELIEF, INC.**

ARTICLE II

CORPORATE EXISTENCE

The corporate existence of this corporation commenced with the earlier filing of the Articles of Incorporation on June 19, 2006, and shall exist perpetually thereafter, unless dissolved sooner in accordance with the law.

ARTICLE III

PURPOSE

- a. This corporation is organized exclusively for charitable, religious, educational, and scientific purposes under section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code.

- b. Upon the dissolution of this corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, or for a public purpose.
- c. Specific nature of the objectives and purposes of this corporation is to provide Emergency and Primary Medical Care to the indigent people in Afghanistan by establishing Medical Clinics, distributing medications, and performing all such other services that would promote well being of those in-need regardless of their faith, color, ethnic origin, or gender, and to perform all such lawful acts that shall aid in the achievement of these objectives and purposes.

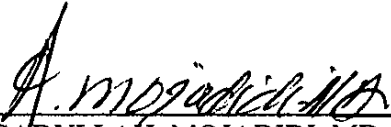

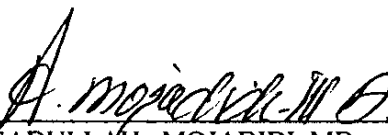
