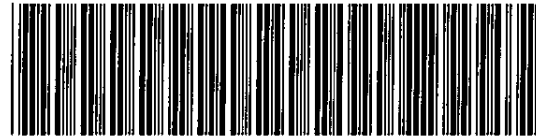

**ARTICLES OF INCORPORATION**  
**OF**  
**TRINITY WORSHIP CENTRE INTERNATIONAL, INC.**

**ARTICLE I -- NAME**

The name of the Corporation is Trinity Worship Centre International, Inc.  
1925 NE 45TH STREET SUITE 234, Ft. Lauderdale, Fl. 33308

**ARTICLE II -- DURATION**

The Corporation shall have perpetual existence.

**ARTICLE III -- NON-PROFIT STATUS**

Trinity Worship Centre International, Inc., shall be a corporation Not For Profit, under the guidelines of the Internal Revenue Service Exemption Status 501 © 3.

**ARTICLE IV -- CHARTER**

Trinity Worship Centre International, Inc. is chartered under the laws of the United States of America and the State of Florida.

**ARTICLE V -- MISSION**

Trinity Worship Center International, Inc. is an inter-denominational Christian Organization of Born Again Believers, male and female, who have heeded the clarion call of Jesus Christ – John 3:7 “ye must be born again” and “unless ye humble yourself as a little child ye cannot enter the Kingdom of Heaven.” II Corinthians 5:17. Ephesians 4:11.

The mission of this Organization is to preach the gospel of our Lord and Saviour, Jesus Christ, predicated uncompromisingly on the Holy Scriptures, divinely inspired by God, the Creator of the Universe and the human race, and that the King James Version shall at all times and in all places be rule and guide for governing the New Testament Church and those who are born again and are in fellowship with Christ, likewise, believers in the faith.

This Organization is and shall be empowered to preach and/or proclaim the Gospel of our Lord and Saviour, Jesus Christ, throughout the world, without hindrance of any municipality, city, county, state or federal government.

This Organization endorses the commission of Jesus Christ as is given in the Gospel according to St. Matthew 28:19-20.

## **ARTICLE VI -- MEMBERSHIP**

The Organization shall be further comprised of men and women who have identified themselves as being called of God to preach His Gospel, and who are called to the sacred ministries of Pastor, Evangelist and teacher.

## **ARTICLE VII -- ORDINATION**

Trinity Worship Centre International, Inc. will from time to time ordain men and women to the Gospel Ministry, whom have so evidenced by their lives and fruit of the Spirit that they have been called by God to preach the Gospel of His Great Commission throughout the world.

## **ARTICLE VIII -- OUTREACH**

Trinity Worship Centre International, Inc. shall engage in and be supportive of Christian Education, Social Services, Scientific Research, and other Charitable Agencies, where there is no conflict or compromising of the teachings of our Lord and Saviour, Jesus Christ.

Trinity Worship Centre International, Inc. shall propagate the Gospel of Jesus Christ by the medium of printed literature, news media, newspapers, journals, tracts, radio, books, Bibles, television and/or any other legal sources open and/or made available for the presentation of the Gospel to the world.

## **ARTICLE IX**

Trinity Worship Centre International, Inc. unapologetically believes that each person and family reserves the right to worship his Creator to the dictates of his, her or their consciences; therefore, religious and/or formal education is theirs to select and or pursue. However, the establishing of Christian Day Care Centers, Kindergartens, Elementary, Secondary Schools and Colleges shall be inclusive of the Association's World Christian Ministry.

## **ARTICLE X**

Trinity Worship Centre International, Inc. shall also buy, sell, lease, hold in trust, and develop real property for its membership, and/or assist where necessary, its autonomous and/or affiliated church organizations in similar pursuits, endeavors and undertakings.

## **ARTICLE XI**

That Bishop Gerald Green is the undisputed founder of Trinity Worship Center International, Inc., and inclusive of being founder, shall hold the office of General Superintendent of the Association at large.

## **ARTICLE XII**

That the General Superintendent shall appoint, nominate and/or cause to be elected all the other necessary officers to their offices, for the growth and/or furtherance of the Organization. The General Superintendent of the Organization shall not be removed from his office unless he brings disrepute to God's sacred ministry and/or the law of a governing state. However, should this be a proven fact, and he is found guilty, he is in the first place reprovved by seven (7) impartial, consecrated and ordained ministers and two (2) lay persons; and if proven guilty beyond all reasonable doubts, and he repents he should be restored to the office of General Superintendent of the Organization.

## **ARTICLE XIII**

That Bishop Gerald Green is the Founder, and elected to the office of International Coordinator of the Organization, and shall not be removed from the said office, except that he brings disrepute to the said office and ministry of the Gospel of Jesus Christ and the Trinity Worship Centre International, Inc. However, should this be a proven fact and he is found guilty, he shall be reprovved by seven (7) impartial and consecrated ordained ministers and two (2) lay members; and if proven guilty beyond all reasonable doubts, and he repents he should be restored to the office of International Coordinator in the ministry.

## **ARTICLE XIV -- INITIAL BOARD OF DIRECTORS**

The initial Board of Directors shall consist of seven (7) members. The number of directors may be increased or decreased from time to time by vote of the majority of directors, but in no case shall the number of directors be less than three or more than seven. 


