ARTICLE I - NAME

The name of this corporation shall be: **TERRY'S KIDZ INCORPORATED**, a non profit corporation.

ARTICLE II - PRINCIPAL OFFICE

The principal place of business and mailing address of this corporation shall be:

2121 W. Pine St. - Tampa, Fl 33607

ARTICLE III - PURPOSE

This corporation is organized exclusively for non-profit purposes, more specifically to care for foster children under child protected agencies. To this end, the corporation is committed to the total care and safety of all youth that are being serviced. To provide a facility where youth can learn to respect themselves and others. To develop community based training for our clients to help develop strong and respectable community values. To shelter, nourish and protect the clients within all guidelines of the law. To actively seek funding through grants, donations and government subsidies, provided for this purpose.




