## EXHIBIT "A"

## ARTICLE III

#### **PURPOSE**

The Association is incorporated for the following purposes:

- a. To own and convey property.
- b. To operate and maintain the surface water management system facilities, including all inlets, ditches, swales, culverts, water control structures, retention and detention areas, ponds, lakes, floodplain compensation areas, wetlands and any associated buffer areas, and wetland mitigation areas within retain center.
  - To establish rules and regulations.
  - To assess members and enforce assessments.
  - e. To sue and be sued.
- f. To contract for services to provide for operation and maintenance of the surface water management system if the association contemplates employing a maintenance company.
  - g. To require all the lot owners, parcel owners, or unit owners to be members.
- h. To exist in perpetuity; provided however, that if the Association is dissolved, the control or right of access to the property containing the surface water management systems facilities shall be conveyed or dedicated to an appropriate governmental unit or public utility, and that if such dedication is not accepted, then the surface water management system facilities shall be conveyed to a non-profit corporation similar to the Association.
- i. To take any other action necessary for the purposes for which the association is organized.
