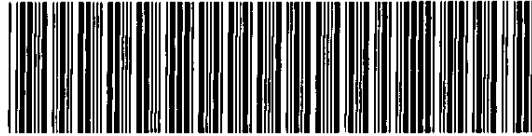

BEFORE THE HONORABLE JUDGES OF THE CIRCUIT COURT OF THE FIFTH JUDICIAL CIRCUIT IN AND FOR INDIAN RIVER COUNTY, STATE OF FLORIDA, IN CHANCERY SITTING, OR EITHER OF THEM:

We, the undersigned, hereby associate ourselves for the purpose of becoming incorporated under the laws of the State of Florida, applicable to corporations not for profit, under the following proposed charter:

ARTICLE I

Name:

The name of the corporation shall be TAXPAYERS ASSOCIATION OF INDIAN RIVER COUNTY and its principal place of business shall be located in Vero Beach, Indian River County, State of Florida.

ARTICLE II

Object:

An association of taxpayers banded together to obtain timely information for its membership of any action which would tend to affect the property of the taxpayer through the workings of any civic body or the branches thereof. To be an association for a debating or literary society. And, to be a scientific institution of learning promoting the welfare of the members of the association and to the community as a whole.

ARTICLE III

Admission:

Taxpayers of Indian River County - on written application and admitted to membership when approved by a majority of the Board of Directors of the Association.

ARTICLE IV

Term:

This corporation shall be in perpetuity existence.

ARTICLE VIII

The By-Laws of the corporation are to be made, altered or rescinded by the Board of Directors of the Corporation subject to approval of majority of Members present at meeting after due notice thereof has been given to the Membership.

ARTICLE IX

Indebtedness

The amount of indebtedness or liability to which the corporation may at any time subject itself shall never be more than two thirds (2/3) of the assets of the corporation.

ARTICLE X

Value of Real Estate

The amount in value of the Real Estate which the corporation may hold, subject always to the approval of the Circuit Judge, shall be \$50,000.00.

ARTICLE XI

Amendment to Charter

The corporation may at any time call a meeting of the membership of the Association for the purpose of making amendment or amendments to the Charter of the corporation. A notice of the meeting must be mailed to each member of the Association and a notice of the proposed amendment or amendments to the Charter must be mailed to each member of the Association; and any amendment or amendments to the Charter of the corporation must be approved by a three-fifths (3/5) vote of those members in attendance at such meeting.
