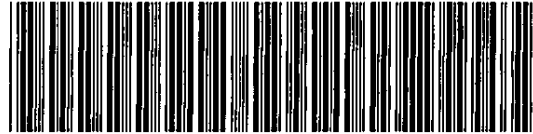

Article One. Name

The name of the corporation shall be Spirit Of Praise Inc.

Article Two Principal Office

Article Three. Purpose

The purpose of this organization is to build a bible centered community based church. We believe the bible is the inspired word of God and the only infallible guide and rule of our faith and practice. The general purposes for which this corporation is organized are exclusively religious, charitable, literary and educational within the meaning of Section 501(c)(3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue Code. Without limiting the generality of the foregoing, Spirit of Praise, Inc. is organized to act as a church for the sole purpose of proclaiming the Gospel of Jesus Christ in an effective and efficient manner.

This corporation shall have the power to purchase, lease or otherwise acquire property, raise funds, and do those things necessary to proclaim the Gospel in an adequate manner.

Notwithstanding any other provision of these articles, this organization shall not carry on any activity not permitted to be carried on by an organization exempt from Federal income taxes under Section 501(c)(3) of the Internal Revenue Code or the corresponding provision of any future United States Internal Revenue law.

The management and affairs of the corporation shall be at all times under the direction of a Board of Directors, whose operations in governing the corporation shall be defined by statute and by the corporation's by-laws.
