

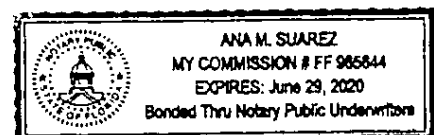

## EXHIBIT "A"

### AMENDMENT TO THE ARTICLES OF INCORPORATION OF DE SOLEIL SOUTH BEACH RESIDENTIAL CONDOMINIUM ASSOCIATION, INC.

Amendment to Article IX of the Articles of Incorporation to provide as follows:

J. Developer shall cause all of its designated Director's to resign three (3) years after sales by Developer of fifty percent (50%) of the Total Units have been Closed or after the Turnover Date, whichever occurs first. ~~when Developer no longer holds at least five percent (5%) of the sum of the Total Units for sale in the ordinary course of business.~~ In addition, Developer may at any time, in its sole discretion, cause the voluntary resignation of all of the Developers designated by it. The happening of either such event is herein referred to as the "Developers Resignation Event". Upon the Developer's Resignation Event, the Directors elected by Members shall elect successor Directors to fill the vacancies caused by the resignation or removal of the Developer's designated Directors. These successor Directors shall serve until the next Annual Members' Meeting and until their successors are elected and qualified; provided, however, nothing contained herein shall be deemed to waive any right to representation on the Board which Developer may have pursuant to the Act. ~~Developer specifically reserves the right to assert any right to representation on the Board it may have pursuant to the Act, notwithstanding that the Developer's Resignation Event may have previously occurred.~~
