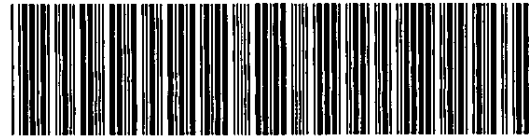




Re: Notice of Resignation
