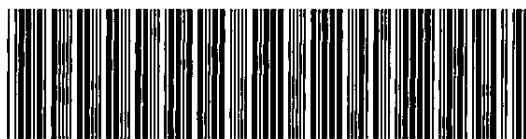

**ARTICLES of INCORPORATION
Of NATURE COAST YOUNG MARINES, INC.**

In Compliance with Chapter 617, Florida Statutes, (Not for Profit), the undersigned acting as incorporators of a corporation benefiting minors, adopt the following Articles of Incorporation:

Article I

The name of the corporation shall be: Nature Coast Young Marines, Inc.

Article II

The principal place of business and mailing address of this corporation shall be: 1293 North Gulf Avenue, Crystal River, Florida 34429.

Article III

The purposes for which the corporation is organized are: The Young Marines is a youth education and service program for boys and girls, ages 8 through completion of high school. The Young Marines promotes the mental, moral, and physical development of its members through instructional and adventurous activities. The program focuses on character building and leadership, and promotes a healthy, drug-free lifestyle. The Young Marines is the focal point for United States Marine Corps' youth Drug Demand Reduction efforts.

Article IV

The manner in which the directors are elected or appointed: The Trustees shall be elected by vote of the registered adult volunteers. Adult volunteers must have submitted a volunteer registration packet through the unit commander to the National Young Marine Headquarters and passed its background check.
