**ARTICLES OF INCORPORATION  
OF**

**THE UNDERSIGNED, acting as incorporator of a corporation pursuant to Chapter 617, Florida Statutes, adopts the following Articles of Incorporation:**

**ARTICLE I.**

**The name of the Corporation is:**

**ARTICLE II.**

**The Corporation shall exist perpetually commencing with the filing of these Articles of Incorporation with the Department of State, unless dissolved according to law.**

**ARTICLE III.**

**The general purposes for which the Corporation is organized are exclusively religious, charitable, literary or educational within the meaning of Section 501(c)(3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue Code. Without limiting the generality of the foregoing, Calvary Chapel of Deerfield Beach, Inc., is organized to act as a church for the sole purpose of proclaiming the Gospel of Jesus Christ in an efficient manner.**

**This Corporation shall have the power to purchase, lease or otherwise acquire property, support missionaries and missions, raise funds and do those things necessary to proclaim the Gospel in an adequate manner.**

**Notwithstanding any other provision of these articles, this organization shall not carry on any activity not permitted to be carried on by an organization exempt from Federal income Taxes under Section 501(c)(3) of the Internal Revenue Code of 1986 or corresponding provision of any future United States Internal Revenue law.**

**No part of the net earnings of the Corporation shall inure to the benefit of, or be distributed to, a director, officer of the Corporation or any member of the Corporation or**
