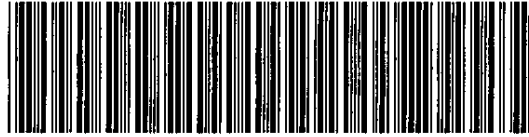

ARTICLE I NAME

The name of the corporation shall be: **Polk County Faith Alliance, Incorporated**

ARTICLE II PRINCIPLE OFFICE

The principal place of business and mailing address of this corporation shall be:

ARTICLE III PURPOSE

The purpose for which the corporation is organization is:

To provide opportunities for members of the Polk County Faith Alliance to collaborate on projects in the community; share ideas and brainstorm solutions that our county faces; apply for and receive funding for community service or economic development projects; and participate in trainings, workshops and technical assistance as provided by the Polk County Faith Alliance. Polk County Faith Alliance is organized exclusively for charitable and educational, including such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501(c) 3 of the Internal Revenue code, or corresponding section of any future federal tax code.

ARTICLE IV MANNER OF ELECTION

The manner in which the directors are elected or appointed:

The President of the organization by virtue of his office shall be Chairman of the Board of Directors. The directors are appointed by the Chairman and President and approved by a unanimous vote of the remaining board of directors, the first term, and then subsequently nominations from the Board of Directors are given to the Advisory board to be voted and approved by the Advisory Board by a two-thirds majority. All executive board members must be residents of Polk County.
