ARTICLES OF INCORPORATION

OF

WOMEN IN THE ARTS, INC

A Non Profit Corporation

The undersigned, being over the age of eighteen (18) years and competent to contract, for the purpose of organizing a Corporation not-for-profit pursuant to the laws of the **State of Florida**, does hereby adopt the following Articles of Incorporation, and does hereby agree and certify as follows:

ARTICLE I

NAME

The name of this Corporation shall be WOMEN IN THE ARTS, INC

ARTICLE II

PRINCIPAL OFFICE

The physical and mailing address of the principal office of the Corporation shall 8150 DIAMOND COVE CIRCLE, ORLANDO, FL 32836

ARTICLE III

PURPOSE AND POWERS

(1) The purpose for which the Corporation is organized and operated is exclusively for charitable, religious, educational, and scientific purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501(C)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code. Such purposes shall include the following:

- (2) As a means of accomplishing the above purposes and methods, the Corporation shall have the following powers:
- (a) To receive and accept gifts of money and property and to hold the same for any of the purposes of the Corporation and its work.
- (b) To raise and assist in raising funds for the purposes herein set forth, including the issuance of bonds or other instruments of credits.
- (c) To acquire, own, lease, mortgage and dispose of property both real and personal.
- (d) To accept property and donations in trust for religious or charitable purposes.



- (3) The property of the Corporation is irrevocable dedicated to religious, educational and charitable purposes, and no part of the net earnings of the corporation/organization shall inure to the benefit of, or be distributable to its members, trustees, directors, officers or other private persons, except that the corporation/organization shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of Section 501 (c)(3) purposes.
- (a) No substantial part of the activities of the corporation/organization shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation/organization shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of, or in opposition to, any candidate for public office.
- (b) The Corporation shall not:
- (1) operate for the purpose of carrying on a trade or business for profit;
- (2) accumulate income, invest income, or divert income, in a manner endangering its exempt status; or
- (3) except to an insubstantial degree, engage in any activity or exercise any powers that are not in furtherance of the purposes of the Corporation.

ARTICLE IV

MANNER OF ELECTION

Directors shall be elected as set forth in the Corporation's Bylaws.

ARTICLE V

INITIAL BOARD OF DIRECTORS

This Corporation shall have four (8) directors initially. The number of directors may be either increased or diminished from time to time in accordance with the Bylaws, but shall never be less than three (3). The name and street addresses of the initial directors of this Corporation are:

- (b) Upon dissolution of this corporation/organization assets shall be distributed for one or more exempt purposes within the meaning of Section 501(C)(3) of the Internal Revenue Code, or corresponding section of any future Federal tax code, or shall be distributed to the Federal government, or to a state or local government, for a public purpose.

Mission Statement

Women in the Arts, is a nonprofit organization dedicated to promote and raise public awareness of women's contributions to the Arts, including performing, visual, written and fine arts. Women in the Arts celebrate and honor the genius of women, their artistic abilities and expressions through hosting an annual exhibit and fundraising event. Proceeds from all fundraising will be used to create scholarships and grants for the benefit of females of all ages to enrich and bring healing to their lives through artistic expression.

Goals

They are deprived of becoming well-rounded students and people. With little or no exposure to the Arts, they are denied the opportunity to develop artistic abilities that could lead to a possible career. Art enriches people's lives through creativity. It feeds the soul.

Why Fundraise

We firmly believe that we are to fundraise through Art to reach out to females who have suffered physical, financial or emotional hardship. Our award would allow these women to approach Art as a healing experience, to restore their soul.

The beneficiaries of scholarships and grants can be, and are not limited to:

- Females that had or are suffering a major illness (i.e.: cancer, heart attack, stroke, Alzheimer's)
- Females who have survived violence or abuse
- Single mothers, women of exceptional courage, women with disabilities
- In Memory of females who passed on due to a certain suffering. The scholarship or grant would be awarded to a female relative.

How to apply for a Women in the Arts scholarship and/or grants:

The recipients are to be nominated by the head of an organization, development officers, volunteer coordinators, individuals or the Women in the Arts Board members.

The availability of scholarships and grants is to be advertised through the media outlets, trade publications, art associations and organizations that provide education, support and healing for females.

The award recipients will be selected by the Women in the Arts Board members with the assistance of quest judges.

Relatives of Board Members are eligible for a one time only honorary award that does not include money or gifts. If a nominee is an acquaintance of one or more of the Board Members, those Board Members are not to be present, nor allowed voting privileges to award this individual. A guest judge or a panel of guest judges is invited to vote.
