Articles of Incorporation of Apopka/Altamonte Springs Veterans of Foreign Wars of the United States Post 10147 Foundation, Inc., a Florida Not For Profit Corporation

The undersigned persons, acting as incorporators of a corporation not for profit under the Florida Not For Profit Corporation Act, as set forth in Chapter 617 of the Florida Statutes, adopt the following Articles of Incorporation for such corporation:

Article I

The name of the corporation is Apopka/Altamonte Springs Veterans of Foreign Wars of the United States Post 10147 Foundation, Inc.

Article II

The corporation shall have a perpetual existence subject to the laws and provisions of the State of Florida.

Article III

The corporation is a not for profit corporation. The purposes for which the corporation is organized are

- (a) The specific and primary purposes for which this corporation is formed are to operate for the advancement of religious and for other charitable purposes, by the distribution of its funds for such purposes and particularly for dedication to the service and support of the Catholic church for the well-being of individuals.
- (b) The general purposes for which this corporation is formed are to operate exclusively for such religious and charitable purposes as will qualify it as an exempt organization under Section 501(c)(3) of the Internal Revenue Code of 1986 or corresponding provisions of any subsequent federal tax laws, including, for such purposes, the making of distributions to organizations which qualify as tax-exempt organizations under that Code.

Article IV

The corporation is organized upon a nonstock basis as defined in Section 617.011 of the Florida Statutes. The corporation shall have a membership distinct from the board of directors. The authorized number and qualifications of the members of the corporation, the manner of their admission, the different classes of membership, if any, the property, voting, and other rights and privileges of members, and their liability for dues and assessments and the method of collection thereof, shall be as regulated in the bylaws.

Article V

The powers of this corporation shall be exercised, its property controlled, and its affairs conducted by a board of directors.

The manner in which the officers and directors are elected and/or appointed is contained in our bylaws which have been, and must be, approved by the state and national organization of the Veterans of Foreign Wars which was created by an act of the congress of the United States of America.

Article IX

Subject to the limitations contained in the bylaws and any limitations set forth in the Not For Profit Corporation Act of Florida described above, concerning corporate action that must be authorized or approved by the members of the corporation, the bylaws of this corporation may be adopted, either by a resolution of the board of directors or by following the procedure set forth therefore in the bylaws.

Article X

The property of this corporation is irrevocably dedicated to charitable purposes and no part of the net income or assets of this corporation shall ever inure to the benefit of any director, officer, or member thereof, or to the benefit of any private individual.

Article XI

Upon the dissolution or winding up of this corporation, its assets remaining after payment, or provision for payment, of all debts and liabilities of the corporation, shall be distributed to a not for profit fund, foundation, or corporation which is organized and operated exclusively for religious or charitable purposes and which has established its tax exempt status under Section 501(c)(3) of the Internal Revenue Code of 1986, or corresponding provisions of any subsequent federal tax laws.

Article XII


