**Articles of Incorporation
Of

We, the undersigned incorporator hereby make subscribe, acknowledge and file with the Secretary of State of Florida, these Articles of Incorporation for the purpose of forming a non-profit corporation in accordance with the laws of the State of Florida.

Article I

The name of the Non-Profit Corporation shall be:

Article II

The principle office of this Non-profit Corporation shall be:

Article III

The general nature of the business to be transacted by this Non-profit Corporation or the objects and purpose of the corporation shall be:

The purpose of the South Florida Dawgs is to provide many opportunities through programs and tournaments to reach amateur athletes through the game of basketball. The general nature of business is to enrich the lives of youth by providing the game of basketball in a positive and rewarding environment.

Section (2) The organization is organized exclusively for charitable, religious, educational and scientific purpose under section 501 (c) (3) of the Internal Revenue Code or corresponding section of any future federal tax code.
