(A Florida Not For Profit Corporation)

ARTICLE I.

The name of this corporation is **OCEAN GARDEN ASSOCIATION**, **INC.** The principal office address of the corporation shall be **102 S. Peninsula Drive**, **Daytona Beach**, **Florida 32118**.
