(C) The property of this corporation is irrevocably dedicated to religious purposes and no part of the net income or assets of the organization shall ever inure to the benefit of any director, officer, or member thereof, or the benefit of any private person.

Upon the dissolution or winding up of the corporation, its assets remaining after payment of, or provision for payment of all debts, and liabilities of this corporation, shall be distributed to a non-profit fund, foundation, or corporation, which is organized and operated exclusively for Religious under Section 501 (C) 3 of the Internal Revenue Code.
