ARTICLES OF AMENDMENTCRETARY OF STATE TO TALLAHASSEE, FLORIDA ARTICLES OF INCORPORATION OF

THE GARCIA STROMBERG FOUNDATION, INC.

Pursuant to the provisions of Section 617.1006, Florida Statutes, THE GARCIA STROMBERG FOUNDATION, INC., a Florida not for profit corporation (the "Corporation"), document number N06000007243 that filed its Articles of Incorporation with the Florida Department of State on July 7, 2006, hereby adopts the following amendments to its Articles of Incorporation:

1. The Corporation's Articles of Incorporation are hereby amended by deleting ARTICLE FIFTH in its entirety and substituting, in lieu thereof, a new ARTICLE FIFTH as follows:

"FIFTH: It is intended that the Corporation shall have and continue to have the status of a corporation that is exempt from federal income taxation under Section 501(a) of the Code as an organization described in Section 501(c)(3) of the Code and which is other than a private foundation as defined in Section 509 of the Code. These Articles shall be construed accordingly, and all powers and activities of the Corporation shall be limited accordingly."

2. The Corporation's Articles of Incorporation are hereby further amended by deleting ARTICLE THIRTEENTH in its entirety and substituting, in lieu thereof, a new ARTICLE THIRTEENTH as follows:

"THIRTEENTH: The Corporation shall initially have three (3) directors to hold office until their successors have been duly elected and qualified, or until their earlier resignation, removal from office or death. The manner of election shall be in accordance with the by-laws. The number of directors may be either increased or decreased from time to time in accordance with the by-laws of the corporation, but at no time shall there be less than three (3) directors.
