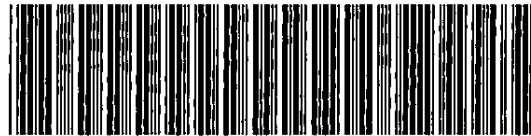

- ONE:* The name and address of this principal corporation is MONZELL D. FORD MINISTRIES, INC. at 1828 Runners Way, N. Lauderdale, FL 33068 in Broward County. The Corporation is organized pursuant to the FLORIDA Non-profit Corporation Code.
- TWO:* The purpose or purposes for which the corporation is formed are as follows: to aid youth and the young at heart towards a life of self-sufficiency. The programs will consist of: Religious Instruction, Counseling, Evangelism, Missions, Radio and Television Broadcast, Gospel Concerts and Outreach Events, Provide Books and other Religious Instructional Manuals, Religious Magazines and referrals to other programs to aid those in need.
- THREE:* The duration of this Corporation shall be perpetual, with no stock and shall have no members.
- FOUR:* The address of the registered office is 1828 Runners Way, N. Lauderdale, FL 33068, and the name of the Registered Agent of the Corporation shall be:

- FIVE:* (1) This Corporation is organized and operated exclusively for Religious and Educational purposes within the meaning of Section 501 (c) (3) of the Internal Revenue Code.
- (2) Notwithstanding any other provision of these Articles, the Corporation shall not carry on any other activities not permitted to carry on (1) by a corporation exempt from federal income tax under Section 501 (c) (3) of the Internal Revenue Code or (2) by corporation contributions to which are deductible under Section 170 (c) (2) of the Internal Revenue Code.
- SIX:* The Directors are elected in accordance with the By-laws. The name and address of the persons appointed to act as the initial Directors of this Corporation are:



EIGHT: On the dissolution or winding up of the Corporation, its assets remaining after payment of, or provision for payment of, all debts, and liabilities of this Corporation, shall be distributed to a non-profit fund, foundation, or corporation, which is organized and operated exclusively for, Education and Religious under Section 501 (c) (3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government for a public purpose. Any such assets not disposed of shall be disposed of by the Court of Common Pleas of the county in which the principal office of the organization is located, exclusive for such purposes or to such organization or organizations, as said Court shall determine which are organized and operated exclusively for such purposes.




