- 3. These Articles of Amendment have been duly adopted by the Board of Directors of the Corporation, by Unanimous Consent effective on January 30, 2008.
- The Articles of Incorporation of the Corporation are hereby amended by the restatement of Article III as follows:

article iii HURPOSES

The Corporation is a not-for-profit corporation, organized and to be operated exclusively for the benefit of, to perform the functions of, and to carry out the purposes of providing financial support for the Miami Residency activities of The Musical Arts Association, an Ohio non-profit corporation which is organized and operated exclusively for charitable, religious, scientific and educational purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code of 1986, as amended (or the corresponding provisions of any future United States Internal Revenue Law) (the "Internal Revenue Code").
