**ARTICLES OF INCORPORATION OF O.C.S.E.O.**

In Compliance with Chapter 617, F.S., (Not for Profit)

SECRETARY OF STATE  
TALLAHASSEE, FLORIDA

**ARTICLE I Name**

The name of the not-for-profit corporation shall be: O.C.S.E.O. CORP.

**ARTICLE II Place**

The principal place of business shall be: 104 NW 102 Street, Miami, Florida 33150

**ARTICLE III PURPOSE**

Said corporation is organized exclusively for charitable and educational purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

**ARTICLE IV MANNER OF ELECTION**

Directors are elected, or for special reasons appointed, by the general membership.

**ARTICLE VI TREATMENT OF EARNINGS**

No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the corporation shall be authorized to pay reasonable compensation for services rendered in furtherance of the purposes set forth in Article Third hereof.

**ARTICLE VII RESTRICTION OF POLITICAL ACTIVITIES**

No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in any political campaign on behalf of or in opposition to any candidate for public office. Notwithstanding any other provision of these articles, the corporation shall not carry on any other activities not permitted by a corporation exempt from federal income tax under section 501(c)(3) of the Internal Revenue Code.

**ARTICLE VIII TREATMENT OF ASSETS UPON DISSOLUTION**

Upon the dissolution of the corporation, assets shall be distributed for exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for public purpose.
