

# ARTICLES OF INCORPORATION

# **REIMS CONDOMINIUM ASSOCIATION, INC.**

(A FLORIDA NOT-FOR-PROFIT CORPORATION)

## ARTICLE I - NAME

The name of this corporation is REIMS CONDOMINIUM ASSOCIATION, INC. The principal address for the office of the corporation is 437 Boundary Boulevard, Rotonda, FL 33947

#### ARTICLE II. - PURPOSES

The purposes and objects of the corporation are such as are authorized under Chapters 617 and 718, Florida Statutes, and include providing for the maintenance, preservation, administration and management of REIMS CONDOMINIUM, pursuant to a Declaration of Condominium recorded in the Public Records of Charlotte County, Florida.

The corporation is organized and operated solely for administrative and managerial purposes. It is not intended that the corporation show any net earnings, but no part of any net earnings that do occur shall inure to the benefit of any private member. If, in any taxable year, the net income of the corporation from all sources other than casualty insurance proceeds and other nonrecurring items exceeds the sum of (1) total common expenses for which payment has been made or liability incurred within the taxable year, and (2) reasonable reserves for common expenses and other liabilities in the next succeeding taxable year, such excess shall be held by the corporation and used to reduce the amount of assessments that would otherwise be required in the following year. For such purposes, each unit owner will be credited with the portion of any excess that is proportionate to his interest in the common elements of the condominium.

## **ARTICLE III - POWERS AND DUTIES**

The corporation shall have all of the common law and statutory powers of a corporation not for profit under the laws of Florida and all of the powers and duties set forth in the Condominium Act, the Declaration of Condominium and the Bylaws to the extent that they are not inconsistent with the Condominium Act.

#### **ARTICLE IV - MEMBERS**

The qualification of members, the manner of their admission and voting by members shall be as follows: Any person or persons or entity that hold(s) title in fee simple to a unit in REIMS CONDOMINIUM, shall, by virtue of such ownership, automatically be a member of this corporation. Each unit owner in the condominium shall have one vote, which vote shall be cast by a designated owner as provided for in the Declaration of Condominium and Bylaws.

#### ARTICLE IV - DURATION

This corporation shall exist perpetually.

## **ARTICLE V - SUBSCRIBERS**

# **ARTICLE VI - REGISTERED OFFICE**

The street address and mailing address of the initial registered office of this corporation shall be: 437 Boundary Boulevard, Rotonda, FL 33947. The name of the initial registered agent at such address is Loris Lakhian.

# \*ARTICLE VII - GOVERNING BODY

The affairs of the corporation are to be managed by a Board of Administration consisting of three (3) Directors. The Directors will be elected each year at the annual meeting of the Corporation as provided for in the Bylaws.

# **ARTICLE X - BYLAWS**

The Bylaws regulating the operation of the corporation are annexed to the Declaration of Condominium. The Bylaws may not be amended without the consent of Developer so long as the Developer holds units for sale in the ordinary course of business at least one (1) unit in the condominium operated by the Association, as provided for in the Declaration and Bylaws.

## ARTICLE XI - AMENDMENTS TO ARTICLES

Amendments to these Articles of Incorporation may be proposed and adopted at any regular or specially called meeting of the members of the Association by the unanimous consent of the members, provided, however, that these Articles may not be amended without the consent of the Developer, so long as the Developer holds for sale in the ordinary course of business at least one (1) unit in the condominium operated by the Association. Due notice of the meeting must be given as provided for in the Bylaws.
