The undersigned, being of legal age and competent to contract, for the purpose of organizing a nonprofit corporation pursuant to the laws of the State of Florida, do hereby state the Articles of Incorporation of BOOKERTOWN IMPROVEMENT ASSOCIATION, INC., in their entirety, and adopt the following Articles of Incorporation and agree and certify as follows:

ARTICLE I NAME

BOOKERTOWN IMPROVEMENT ASSOCIATION, INC.

(Hereinafter a non-profit corporation)

ARTICLE II PRINCIPAL PLACE OF BUSINESS

4631 Gilbert Street Lake Monroe, FL 32747

The property and assets of this corporation are irrevocably dedicated to Charitable, Educational and Literary purposes.

ARTICLE III PURPOSE

The purpose of Bookertown Improvement Association, Inc., is to provide a place where at-risk young girls and boys can come to study for the State of Florida General Education Diploma (GED), learn sports and sportsmanship, engage in activities, receive tutoring and mentoring, receive computer, employment and etiquette training. In addition, the Association would be open to older adults who would also like to receive computer training, as well as, employment skills including how to write a resume, cover letter and go on job interviews. The at-risk youth would learn to have good self-esteem and work towards having a successful educational and employment experience. The Association will provide a food and clothing pantry to assist families in need and will assist single parents with budgeting, life and employment skills. Computer Workshops will be held to enhance the skills of the at-risk youth in the Bookertown community. The Association will work

with the local community college and Seminole County to provide GED classes at the community center and drug prevention classes.

ARTICLE IV MEMBERSHIP

There is active and honorary membership in the organization. The requisite for membership is outlined in the ByLaws of the organization.

connection with any actions taken or failed to be taken by said directors, officers, employees and agents in their capacity as such except for willful misconduct and gross negligence.

ARTICLE VIII BYLAWS
