# ARTICLES OF INCORPORATION

In compliance with Chapter 617, F.S., (Not for Profit)

#### ARTICLE I NAME

The name of the corporation shall be: Iglesia Cristiana Pentecostal de Winter Garden Inc.

#### ARTICLE II PRINCIPAL OFFICE

The principal place of business and mailing address of this corporation shall be: 820 South Park Avenue, Winter Garden, FL 34787

#### ARTICLE III PURPOSE

The purpose of this church shall be to maintain and preserve the spiritual and unity of its members and to visibly share Christ's life, forgiveness and salvation among ourselves and in our community and in the World by regular preaching of the Word of God and Holy Sacraments.

This church is a nonprofit ecclesiastical corporation organized and operated exclusively for religious purposes within the meaning of Section 501(c)(3) of the United States Revenue Code of 1986, as now enacted or hereafter amended (or corresponding provision of any future United States Internal Revenue law) (the Code). The church shall not carry on any activities not permitted to be carried on (a) by a corporation exempt from federal income tax under Section 501 (c)(3) of the Code or (b) by a corporation contributions to which are deductible under Section 170 (c)(2) of the Code. This church has not been formed for pecuniary profit or gain. No part of the assets, income, or profits of the church shall insure to the benefit of its members, council members, trustees, or officers or to any individual. However, the church shall be authorized to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in this Article III.

No substantial part of the activities of this church shall consist of carrying on propaganda, or otherwise attempting to influence legislation. This church shall not participate or intervene in (including the publishing or distribution of statements) any political campaign on behalf of any candidate for public office.
